

Hottest February day in Ahmedabad since 1990: Mercury@38.2 degree Celsius



AHMEDABAD: Relentless city and state. Sunday's heat continues to singe the maximum temperature of

38.2 degree celsius for Ahmedabad made it the hottest February day for the city since 1990, according to India Meteorological Department (IMD) data. The previous hottest day of the month was three years ago on February 24, when the mercury touched 37.8°C.

Sunday was not only the hottest day for Ahmedabad, but for at least four other cities and towns that recorded unusually high temperatures. They included Rajkot, Surendranagar, Amreli and Keshod. Except Ahmedabad, all four other weather stations recorded temperatures of 39 degrees celsius or above.

While it's usual for the state to experience hot weather, with maximum temperatures often breaching 40 degree celsius March onwards, this year, however, the heat is making its presence felt mid-February.

Compared to normal winters, November 2022 to February saw a relatively warm winter with fewer days recording minimum temperature of 10°C, said Met department officials. According to the IMD records, in the past five years, the month of February recorded five hottest days. Except in 2023, the previous hottest days were recorded towards the end of February.

While the forecast for the season is yet to be officially made, experts anticipate a searing summer for the state based on the early onset of heat. "Maximum temperatures very likely in the range of 37-39 degree celsius in parts of North Gujarat region and Saurashtra-Kutch during the next two days," mentions the IMD forecast. In Ahmedabad, the maximum temperature is likely to be around 38 degree celsius, indicated the forecast.

At 39.8°C, Rajkot recorded the highest maximum temperature on Sunday. In all, eight weather stations recorded maximum temperatures of 38°C or more.

No spoiler: Confessions of an embalmer

SURAT: His morbid fascination with preserving what will eventually perish may leave some of us thinking about the utility of the process. Dr Vinesh Shah, however, is dismissive of such "uncompassionate curiosity" and believes his job is the epitome of kindness to humanity. An expert in embalming, he remains an unsung hero because those who could have thanked him shall never speak. Embalming is the process of preserving the human body in its natural form by delaying its decomposition. It involves

injecting a combination of chemicals into the body after taking into account its physical features and weight. In many cases, embalming also involves restoring dismembered bodies. Since 2014, Dr Shah and his team have carried out embalming of over 75 jawans of Border Security Force (BSF) who lost their lives in the line of duty. A PhD in forensic medicine, he runs a forensic and medico-legal consultancy that is officially tasked with embalming bodies for the BSF. The team ensures that the jawan's body reaches his

home in an identifiable condition for the last rites. According to the regulations in many countries, embalming is international and domestic transit of the deceased. "The airlines demand a certificate from doctors stating the body will be in good condition for at least three days. Our process stalls decomposition for up to seven days," Shah said. He took to embalming after coming across cases where families struggled to preserve bodies that either had to be transported to remote places or stored till the relatives arrived for the funeral.

Mixed bag for groundwater in Gujarat cities: LS data

Ahmedabad: A data on the water levels in urban areas of India tabled in the Lok Sabha recently gave a mixed picture for the Gujarat cities. While data of Rajkot was not included, readings from nine borewells of Central Ground Water Board (CGWB) in Ahmedabad, Surat and Vadodara were used to ascertain how the levels have changed over a period of 10 years - from November 2012 to November 2022.

According to the data, out of four wells in Ahmedabad, two each saw rise and fall in the water levels. The rise and fall were in the range of 0 to 2 metres depth. The only borewell in

Surat saw the rise of 0 to 2 metres, whereas in Vadodara three out of four wells saw a rise by 0 to 2 metres. One well in Vadodara saw a fall in water level by more than 4 metres.

Experts pointed out that the water levels are often average of the said aquifer. They pointed out that the depletion in groundwater in urban areas is no secret, but in Gujarat the scenario has improved in some areas due to availability of Narmada water which has reduced dependency on exploiting the groundwater for drinking purposes.

'Yuvati Shibir' against love jihad held in Gandhinagar

GANDHINAGAR: The Gandhinagar unit of Durga Vahini - the women's wing of the Vishwa Hindu Parishad (VHP), organised a day-long 'Yuvati Sammelan' in the state capital on Sunday, "with the aim of educating Hindu girls about the perils of love jihad."

According to the VHP and Durga Vahini, about 1,100 women and girls from Gandhinagar district participated in the event. Durga Vahini Prant convener Nupurben Patel said, "More than 1,000 girls and women between the ages of 15 and 35 were educated "about the perils of love jihad and mehndi jihad. Slides were shown of how girls got lured by person of another religion and all of them suffered after marrying," she said. Durga Vahini will hold a training session from May 7 to 14 where girls and women between the ages of 15 and 35 will be trained in self defense. "Girls and women will be trained in using sticks, swords and rifles as part of the training programme," Patel said.
