

Rain creates havoc in Guntur, Palnadu districts

INCESSANT rains during the last two days created havoc in Guntur and Palnadu districts.

A youth Boppudi Ramu (22) was reportedly washed away in Kuppanjivagu floodwater at Kavuru village of Chilakaluripet mandal of Palnadu district on Friday night. This incident came to light on Saturday. Road connectivity was cut off be-

tween Amaravati and Vijayawada city due to overflowing of floodwater onto the road at Pedamadduru near Amaravati of Palnadu district. As a result, bus services were diverted. Kondaveetivatu was filled to the brim and floodwater of the steam inundated the road at Pedaparimi. Heavy rain inundated cotton and chilli fields in thousands of acres in Krosuru, Achampet and Amaravati mandals of Palnadu district and Tadikonda mandal of Guntur district. The farmers fear

severe loss to cotton and chilli crops. However, the officials hoped that the rainwater will recede. Following heavy inflows of floodwater into the Pulichintala project, the engineering officials of the project lifted 15 crest gates and released 4.07 lakh cusecs of the floodwater to the downstream. Guntur district administration alerted the revenue and police officials to take precautionary measures and instructed the people residing in low-lying areas in Thulluru, Mangalagiri, Kollipara

ployees. Women were seen weeding out rainwater with buckets in several areas. Drains were blocked in several areas the drain water overflowed on to the roads.

Rainwater entered Peekalavagu drain at A T Aghraharam and inundated the road. An auto-rickshaw was stuck in the rainwater at Peekalavagu. However, no property loss was reported so far.

GMC Commissioner Kirthi Chekuri instructed the officials to alert the families residing beside the Peekavagu drain as it is overflowing following heavy rain. The sanitary workers were instructed to remove any blockages in the drain for the smooth flow of drain water.

Construction of 20L houses will be completed by next March: Minister

MINISTER for Municipal Administration Audimulapu Suresh said that the State government had distributed 30 lakh houses sites to the poor, out of which 20 lakh beneficiaries started houses construction and these houses will be completed by next March end.

He unveiled the pylon and handed over the TIDCO houses constructed at YSR Jagananna Nagar in Mangalagiri on Saturday and distributed sale deeds to the beneficiaries.

Speaking on this occasion, he said that the State government constructed 1,728 houses on 15 acres of land in Mangalagiri to the poor and assured that efforts would be

made to develop infrastructure at other colonies in Mangalagiri town.

District Collector M Venugopala Reddy said that all the beneficiaries conducted the house warming ceremony on Saturday in Mangalagiri and added that the State government provided drinking water facility and other infrastructure at the housing colony.

MLA Alla Rama Krishna Reddy said that the district administration had set up hospital, school, park and electrical sub-station at the housing colony.

MLC Murugudu Hanumantha Rao, TIDCO Managing Director Ch Sridhar, Joint Collector and Tadepalli-Mangalagiri Municipal Corporation special officer G Rajakumari were present.

Road-cum-rail bridge repairs may last more than a week

A preliminary inspection by the officials on Saturday revealed that the repairs of the temporarily closed road-cum-rail bridge may take more than a week than the officials initially announced. MP Margani Bharat along with the Railway and R&B officials inspected the bridge to assess the repairs to be undertaken on the road-cum-rail bridge on Saturday evening.

The lifetime of this bridge which was built in 1974 was 60 years, so far 48 years have passed. The MP stated that the railings, footpath and road were damaged. He said that the railing has tilted up to a length of 10 metres on one side. He said that the State gov-

ernment would sanction Rs 11 crore for these repairs. The MP opined that as the lifetime of this bridge is coming to an end, proposals for another new bridge should be prepared.

At present, apart from temporary repairs, it is expected to carry out full-scale maintenance work for this bridge, he said. It has been suggested to remove the concrete railing and install a steel railing.

Closure of bridge causes hardship to commuters

THE sudden decision to ban traffic on the road-cum-rail bridge between Rajamahendravaram and Kovvur over River Godavari for a week has resulted in causing a lot of inconvenience to the local people.

Early morning on Friday, stoppers were placed at the beginning of the bridge, prohibiting the entry of vehicles. RTC buses and heavy vehicles going from Eluru via Kovvur to Rajamahendravaram were diverted via Gammon Bridge. Some buses are plying through Katheru and some buses are plying through Konthamuru.

Two-wheelers, autos and cars are being diverted to Vijeshwaram via Dowleswaram barrage road. The sudden closure of the bridge caused difficulties to transporters who had already obtained permits on this

route. The approach road to the fourth bridge or Gammon Bridge over the Godavari is full of potholes and is in a bad condition.

Also, the Dowleswaram Barrage Road has become hell with potholes. Passengers were distressed as these were the only alternative routes. Drinking water pipeline repairs are being done on a large-scale at Alcut Gardens, Kotipalli bus stand, railway station, etc. Vehicles coming from Dowleswaram and vehicles going over the barrage should use this road. Due to this, there is traffic congestion and people are suffering. The road will be completely inundated when it rains and as the road is full of potholes, the problems are compounded for the commuters. Due to the increase

in the movement of heavy vehicles, traffic jams are being reported at Katheru and Konthamuru.

K Raju, an employee, pleaded for exemption for emergency and daily moving employees. Sivaram, a private employee said that he was working in a studio.

He lamented that he had to travel an additional 10 kilometres on the very bad potholed road to reach Kotipalli bus stand from Kovvuru. Naga Raju from Malakapalli near Kovvuru had to come via Vadapally and Vijeshwaram to take Marud to the hospital. Due to this, he reached two hours late. Satyanarayana, a taxi driver, requested that the toll tax on the Gammon Bridge be lifted until the road-cum-rail bridge is repaired and reopened.

YSRCP cadres try to obstruct farmers' yatra at Chagallu

A large number of YSRCP workers greeted Maha Padayatra of Amaravati farmers with black balloons in Chagallu mandal of Kovvur constituency which is represented by home minister Taneti Vanitha, on Saturday.

As the ruling party supporters tried to obstruct the march, police, who were deployed in large numbers, erected barricades separating the two sides. Except YSRCP, activists of all other parties, including TDP, BJP, Jana Sena, CPI and CPM supported the farmers and raised slogans in favour of keeping Amaravati as the only capital. Hundreds of women also participated in the demonstration in support of the farmers.

Police allowing rallies by both opponents and supporters of padayatra has become a topic of discussion among public. The police turned a blind eye on Friday, when YSRCP leaders attempted to disrupt the farmers' march in Nidadavole. Police allowing both sides to show their strength during yatra is being criti-

cised by people as this could lead to confrontations.

Meanwhile, the march by farmers is evoking huge public response. Crowds are turning up enthusiastically to support the marching farmers ignoring rain.

Former minister KS Jawahar criticised the state government for obstructing the yatra at every step. Chief Minister Y S Jagan Mohan Reddy cannot tolerate the great response that farmers were evoking

during this yatra, he said. Padayatra is dedicated to the protection of Amaravati and the state's development. Closing the road-cum-rail bridge on the pretext of repairs at the time of the padayatra is direct proof of the impatience of the government, he alleged. Jawahar described Amaravati as the capital of Dalits. TDP leader Jonnalagadda Subbaraya Chaudhary said that the people's support for the Amaravati farmers' march is overwhelming.

When Home Minister Taneti Vanitha was asked about her reaction to the farmers' march that entered the Kovvur constituency, she claimed that yatra was not getting public support anywhere. She alleged that TDP leaders are doing this trip for their selfish interests. MP Margani Bharat Ram told Hans India that Amaravati real estate yatra is being opposed in all districts. All should oppose such attempts to incite regional differences, he said.
