Uppal man, son hacked to death

BRUTAL and bloody murder of a father and son duo in the early hours of Friday shattered the morning peace of Sai Hanuman Nagar in Uppal. The masked assailants came out of the hostel building located right opposite side of the victims' house and hacked 73-yearold Narasimhula Narasimha Murthy to death while he was sitting outside in the early hours. The murder happened in a flash even as the horrorstruck maid servant of the victim watched. She was threatened by the men who appeared to be in murderous mood.

His son Srinivas, 45, came out running upon hearing the commotion and tried to catch one of the killers. But he, too, was slaughtered by the two men. A senior police official said, "The incident took place at around 5:30 am when Narasimha Murthy was sitting outside his house and the maid was sweeping the courtyard. The assailants fled the spot immediately after murdering the father and son.

A dog squad was pressed into service to catch the culprits. The footage of the CCTV cameras in the surrounding areas were checked

A BENCH, comprising Chief Justice Ujjal Bhuyan and Justice CV Bhaskar Reddy, on Friday declared that it found no abnormality in the Munugode voters list provided to the Telangana High Court.

However, the court adjourned further hearing on the writ case filed by BJP State general secretary Gujjala Venkata Krishna Reddy to October 21, while instructing the Election Commission of India (ECI) to submit the most recent updated voter

After reviewing the statement provided by the Chief Election Officer, the bench concluded that "the total voters in Munugode as of October 12, 2018 were 2,14,847, and as of October 11, 2022, this number has increased to 2,38,759. This increase, the bench ruled, was not unusual.

Avinash Desai, standing counsel for the ECI, submitted a signed statement of the Chief Electoral Officer of Telangana and informed the court that pursuant to Section 23(3) of the Representation of the Peoples Act, the electoral list for Munugode will be frozen on Friday, the last day of filing of nominations.

As per the CEO's statement, $\,$ the authorities received a total of 25,013 Form 6 applications, of which 7,247 were rejected and 12,249 approved. As of October 11, 2022, a total of 5,517 Form 6 applications were pending. Also, 2,142 Form 8 applications were re-

Those individuals are not before us; you are requesting that they be removed from the voter list; we cannot do so; your decency has been recorded, and the writ petition is still ongoing. If you win by a large margin, that may be the end; if you lose by a small margin, we will look into it.'

Meanwhile, there was a flood of nominations filed for the Munugode byelection on Friday, the last day. As many as 129 candidates turned up to file nominations.

'Honour' killing: Girl's father confesses to killing boy

Speaking to the media, Patancheru DSP S Bheem Reddy said that girl's father Marka Balaperu admitted to killing Sivakumar. The family did not like the fact their daughter and Sivakumar, who belongs to a different caste, were in love.

"We have taken girl's father Marka Balaperu, mother Balakishtamma, brother Marka Anand and their accomplice V Balakrishna into custody on Thursday. Anand's wife Leela

is absconding," the DSP said. Revealing the case details, he said that Shivakumar, originally from Koder village in Nagarkarnool district, was residing in Patancheru along with his parents from some time. He was in love with a young woman, who is also from Koder, and her parents were residing in Bolakpura, Hyderabad.

HMDA officials penalised for delay in building permissions

THE State Government slapped penalty on six officials of the Hyderabad Metropolitan Development Authority (HMDA) and also instructed the district Collectors concerned to impose penalty on 33 other officials, that include Municipal Commissioners and 27 scrutiny officers who delayed the process of TS-bPASS applications.

The Government has enacted TS-bPASS Act 2020 for getting hassle free building permissions online and to facilitate building approval process for citizens in an objective and time-bound manner. It has come to the notice of the Government that there is an extreme delay by some of the officers in processing of applications in the Municipalities, Municipal Corporations and HMDA. The State Government is reviewing the performance of different officials regularly and imposing penalties on erring officials, the order said.

So far, penalties have been levied six times since commencement of TS-bPASS in 2020.

₹1,082-crore cable-stay-cum-suspension

ALMOST two-decade-old dream of the people living on either side of Krishna river separating Telangana and Andhra Pradesh is soon going to be a reality as the Centre has approved the construction of Somasila-Siddheshwaram cable-stay-cum-suspension bridge at a cost of ₹ 1,082.56-crore. The bridge will not only improve the road connectivity between the two States, but will also significantly reduce the travel time.

The demand for the bridge came after a tragic incident on January 19, 2007, when a boat from four villages in Kurnool district to the Laxminarasimha Swamy temple jatara in Singotam on Telangana side of the river, capsized resulting in the death of 61 passengers.

YS Rajasekhara Reddy, the then chief minister of the erstwhile AP, had sanctioned ₹ 50 crore for construction of a bridge, but his untimely death, coupled with political uncertainty later, had left the project in cold storage.

Even though his successor N Kiran Kumar Reddy had sanctioned ₹ 250 crore later, the project couldn't take off. After the formation of Telangana, the State government sanctioned ₹ 190 crore,

but the Andhra Pradesh government did not show any interest in the project.

It was only since 2018, the barriage became an election issue in Kollapur Assembly constituency in Nagarkurnool district, as it is not only a road connectivity issue, but also has a cultural aspect to it, as the people on both sides of the river, though geographically separated, have family connections. What further fuelled the demand was the tourism potential due to the presence of Srisailam reservoir and Nallamala forest in Kollapur.

The Centre had sanctioned ₹ 1,700 crore by extending the 122 km highway to connect Kalwakurthy and Kollapur in Telangana, to Atmakur and Nandyal in AP. With the construction of the bridge which forms part of the highway, the total distance between Hyderabad and Tirupathi is expected to be reduced by 80 km, and would relieve those travelling to Nandyal from going via
