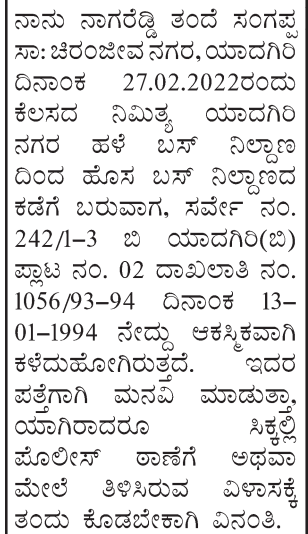
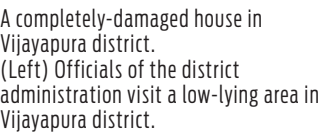

Jiyapura: A 53-year-old farmer died after he was bitten by a snake at Benkotagi village near Sindagi on Wednesday. The deceased is Ningangouda Birad, 53, a resident of Benkotagi and farmer. The incident happened while he was working in his farmland on the outskirts of the village. He is survived by his wife and children. According to the police, "Ningangouda was working in his agricultural land when he was bitten by a snake. He succumbed to the injuries on the spot. He could not be taken to the hospital as there were no people nearby." A case has been registered at the Sindagi police station.
