BHOPAL: The crime branch police have arrested a person who formed a social media page to sell the mobile phones at low prices and had cheated a Bhopal-based businessman. Deputy commissioner of police Amit Kumar told Free Press that in October 2021, a complaint was filed with police. It was stated that he had paid more than Rs 7 lakh to a man to purchase mobile phones at low price. As per deal, he deposited Rs 7 lakh in the account of accused Ashwani Ram Kanan but as soon as the money was deposited, he switched off his phone.

WITH 9 MORE COVID DEATHS, TOLL INCREASES TO 10,616 IN STATE

Bhopal leads with 1,936 cases

Nine more Covid deaths have been reported in the state taking the toll to 10,616 on Sunday, according to state health bulletin. Positivity rate reduced a bit from 11.74% to 11.49%.

Active cases reduced from 66,042 to 63,297. On January 29, deaths were 5 due to Covid, which increased to nine. As many as 80,930 samples were sent for the testing and 406 samples of them were rejected at time of testing.

On Sunday, Bhopal led with 1936 Covid cases followed by Indore with 1,784 cases. Other major cities like Gwalior and Jabalpur reported 228 and 662 cases respectively. Surrounding districts of Bhopal also con-



Balaghat reported 178 Covid cases while Betul reported 181 cases and Chhatrapur reported 110 cases. Similarly, Datia reported 115 cases while Dhar reported 173. Katni reported 159 cases while Khandwa and Khargone reported 109 cases and 154 Covid cases respectively. Ratlam recorded 120 cases. Rewa reported 151 and Sagar reported 115 Covid cases while Sidhi and Seoni reported 102 and 131 cases respectively.

CLASS XI GIRL RAPED BY FRIEND IN HOTEL

A Class XI girl was allegedly raped by a person she had befriended after meeting on Instagram in the Bhanwarkuan area, police said on Sunday. The accused took the victim to a hotel where he spiked her drink and raped her. The accused could not be arrested till the filing of the report.

Bhanwarkuan police station in-charge Santosh Kumar Dudhi said that a case has been registered against a youth named Mayank of Bairathi Colony on the complaint of a 16-year-old victim on Saturday. The victim stated in her complaint that she met the accused through Instagram a few months ago. Later, they started chatting and became friends.

On January 23, they met in the Bhanwarkuan area and he took her to a hotel where he mixed something in her drink and then raped her. When she tried to oppose, the accused threatened to defame her.

After reaching home, the victim was upset and when her mother asked the reason, she revealed the entire incident. Later, she along with her mother reached the police station and complained to the police. The police have registered a case under section 376 and the relevant section of POCSO Act against the accused and started a search for him.

'Berasia gaushala received over Rs 38 lakh from govt'

The Gausewa Bharti Gaushala Basai, Berasia, where hundreds of cows were found dead this Sunday had received Rs 37.69 lakh from the state government for fodder and maintenance of cow shelter. RTI activist Vivek Pandey had sought information under RTI Act from Gopalan evam Pashusamvardhan Board on funds given to various

gaushalas (cow shelters) for fodder and maintenance of the cow shelters for past five years from 2015-16 to year 2020-21. According to reply given by Veterinary Health Services, Bhopal, the Gausewa Bharti Gaushala in Bhopal district received funds amounting to Rs 37,69,058 in last five years. The reply said that as many as 31 gaushalas were given grant in Bhopal district. The state govern-

ment had spent Rs 79,02,669 in 2015-16 on cow shelters. These amount reached Rs 40,00,838 in 2016-17, Rs 1,03,84,073 in

2017-18 and Rs 52,33,375 in 2018-19 for cow shelters in Bhopal district. In 2019-2020 and 2020-21, funds were given to 22 gaushalas in Bhopal district. In 2019-2020, the amount disbursed stood at Rs 10,00,056 while Rs 18,56,800 was given to 22 gaushalas in Bhopal district. In another question, Pandey had asked about number of cow deaths in gaushalas in Bhopal district in past five years from 2015-16 to 2020-21. As per reply, as many as 5,578 cows died in the gaushalas in Bhopal district in last five years. The RTI reply said that 616 cows died in 2015-16, 1847 in 2016-17, 1363 in 2017-18, 907 in 2018-19, 586 in 2019-2020 and 259 cows died in the year 2020-21 in 28 gaushalas in Bhopal district. This includes death of 63 cows in past five years in controversial Gausewa Bharti Gaushala, Berasia.

Tourist killed, 3 injured as boulder falls on car in J&K's Ramban

Banihal/Jammu/Bhopal: A 23-year-old tourist was killed and three others injured when a boulder fell on a car on the Jammu-Srinagar National Highway near Ramban district on Sunday, police said. The vehicle was carrying 12 people from south Kashmir's Pahalgam hill resort to Mata Vaishno Devi shrine in Reasi district. The incident occurred near Cafeteria Morh in the afternoon, they said. Four tourists from Jabalpur in Madhya Pradesh were injured in the incident and taken to a hospital in Ramban where one of them was declared brought dead. One more critically injured patient was referred to Government Medical College and Hospital in Jammu for specialised treatment, they said, adding the vehicle suffered extensive damage in the incident. COURT SENTENCES 7 TO LIFE IN JAIL FOR SETTING ABLAZE, KILLING 4 OF FAMILY

Shivpuri: Seven people were sentenced to life imprisonment by a court in Shivpuri in Madhya Pradesh for killing four persons by setting them ablaze, an official said on Sunday. As per the complaint of Rameshwar Rathore, a resident of Maniyar under Shivpuri Kotwali police station limits, his sister Laxmi's husband Ram-lakhan Rathore, mother-in-law and others started a blaze in a room in which his siblings and parents were sleeping in the intervening night of April 15 and 16, 2015. His complaint filed the next day said his sisters Laxmi and Saraswati, brother Mahesh and mother Gita died in the blaze while father Jagdish survived.
