




Most govt degree colleges in city struggling with poor facilities

▶ Though funds were sanctioned for renovating govt degree colleges in Hyderabad, no step has been taken to refurbish them.

THOUGH funds were sanctioned for renovating the government degree colleges in Hyderabad, no step has been taken to refurbish them. The RTI reply to a petition reveals that of the Rs 16.25 crore allocated to infrastructure development in the colleges Rs 10 crore was set apart for two-degree colleges at Chanchalguda and Falaknuma. Works are yet to commence in these colleges.

Most colleges in the city, including government degree colleges at Neredmet, Chanchalguda, Golconda and Falaknuma, are in dilapidated condition. The Government Degree College at Sithaphalmandi is located on private land. The government has not allocated land; also, all colleges don't have basic facilities.

Robin Zaccheus, social activist, said, "It seems that funds sanctioned for renovating government degree colleges are only on paper. The government claims that the sanctioned amount has been utilized, but the ground reality is no development works have taken place from 2014-2022. All colleges lack washrooms, there are no fans in classrooms, drinking water facility is lacking. There are computer labs without computers."

He said there has been a lack of focus on developing colleges. In the last eight years, the government could take them to the next level

but sadly the government has not focused on developing infrastructure in colleges. The reply I have received regarding the total fund sanctioned for the projects is Rs 16.25 crore. This is under the Centrally-sponsored scheme RUSA, but it has not been utilised.

Why works have not been started. Many colleges don't have drinking water facilities; I have not received a proper reply.

Praneeth, a degree second-year student, said, "we have been facing hardship due to non-availability of proper basic facilities. As there are no washrooms for boys, they are forced to defecate in the open; girls are forced to use dirty toilets. Many representations were given to college authorities and also the Education department, but no concrete measures were taken to develop colleges."

"In Neredmet degree college Inter college is located. Due to that degree students are facing hardship. As there are no classrooms we are forced to sit outside. Also classrooms don't have fans," said Ramesh, another degree student.



Poultry farmers put forth demands before hatcheries

TO discuss the future course of action against the harassment to poultry farmers, their leaders from different districts of the State met on Tuesday at Kompally and deliberated several issues and demands before preparing a resolution to put forth the same before the representatives of hatcheries against whom they are having issues.

According to Sudhakar Rao Machha, State President Telangana Integration Poultry Farmers Association, "Around 400-500 leaders representing the poultry farmers from 15 districts of the State turned up to the meeting to discuss various issues and get details from the reports of harassments the farmers are facing while propagating the poultry." The leaders also put forth few demands for the development of families involved in poultry farming. Demands raised during the meeting include price increase by Rs 15 per kg, revocation of Food Consumption Ration charges, relaxation in using Agriculture bore wells for poultry rearing and free power supply for poultry industry. Later, a delegation of poultry farm leaders called on the representatives of leading hatcheries such as General Manager Venkateshwara Hatcheries Limited Bala Subramanyam and General Manager Suguna Chicken Krishnam Raju.

▶ Demands raised during the meeting include price increase by Rs 15 per kg, revocation of Food Consumption Ration charges, relaxation in using Agriculture bore wells for poultry rearing and free power supply for poultry industry

▶ Farmers urged the representatives of hatcheries to discuss the issues with higher authorities to resolve the matter

The poultry farm leaders made a representation to them and urged them to discuss the demands with the higher authorities taking the poultry leaders into consideration.

Sudhakar Rao informed that they are planning to raise the issue faced by the poultry farmers with the State government soon by calling on Minister K T Rama Rao where we can put forth the demands as well for the overall welfare of the farmers involved in poultry farming. Poultry farm leaders from 15 districts of the State notably Vice President Telangana Integration Poultry Farmers Association Rajeshwar Reddy, General Secretary Sara Srinivas, Pappu Raji Reddy and Ch Srinivas Reddy and other were present in the meeting.
