

Trauma care centre to open its doors for all

KIRAN BALANNANAVAR @Ballari

KALYANA Karnataka's first and state's third Trauma Care Centre that opened in Ballari last year and was serving only Covid infected patients, will now open for all patients from Saturday. It is the third dedicated trauma centre in the state after Bengaluru and Hubballi.

In July 2021, the centre was operationalised and following the second wave of Covid-19, it was only serving the infected

patients. Till today, it is treating only Covid-infected patients. As the third wave is under control now, the district administration has decided to open the trauma centre for all patients from February 12.

Vijayanagar Institute of Medical Sciences (VIMS) director Dr Gangadhar Gowda said under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) scheme, the super-speciality trauma care centre was constructed on the VIMS premises.

Trauma care centres are specific about the treatment of accidents and also emergency health issues. There was no such dedicated centre in the Kalyana Karnataka region

Dr Gangadhar Gowda, Vijayanagar Institute of Medical Sciences (VIMS) director

"Both Union and state governments contributed 80 and 20 per cent funds respectively, for the construction of the centre," he said. "Trauma care centres are specific about the treatment of accidents and also emergency health issues. There was no such dedicated centre in the Kalyana Karnataka region. Last year, Health Minister Dr K Sudhakar inaugurated the centre and it had begun serving Covid-19 patients. In the centre, orthopaedics, neurosurgery, plastic surgery and many other serious cases will be treated," he said and pointed out that around 500 staff are working in this new centre.

No more compulsory testing at airports

IN fresh guidelines for international travellers, issued on Thursday, the Union Government has said there will no longer be compulsory Covid-19 testing at airports, and only random testing will be done on 2 percent of the passengers. However, a RT-PCR negative report within 72 hours will be necessary. Passengers who are Covid-19-negative will not be quarantined. The guidelines will be effective from February 14 and will be implemented at airports,

The self-declaration form will still need to be filled on the Air Suvidha portal and a negative Covid-19

also be uploaded. At the time of boardonly asymptomatic travellers will be allowed after thermal screening. The thermal screening will be repeated on arrival at the airport.

"Passengers found to be symptomatic during screening shall be isolated. If positive, their contacts will be identified and managed as per protocol. The samples of travellers who test positive in random testing shall be sent for genomic sequencing," the circular said.

Travellers from countries which exempt fully vaccinated Indian citizens from quarantine will also be given relaxation of quarantine rules in India, provided they have the complete primary vaccination certificate. The certificate will have to be uploaded on the Air Suvidha portal. The list of these countries is available on the Ministry of Health and Family Welfare website.
