# AP Cabinet to be mix of old & new, **BCs** to get priority

Selection process will be completed today: new team likely to be in place on Monday

ANDHRA Pradesh Chief Minister YS Jagan Mohan Reddy's new team will be sworn in at 11.31 am on Monday. The muhurat for the swearing in ceremony was fixed and the venue would be the vacant space near Secretariat. The Cabinet would be a mix of old (those who resigned recently) and new and BCs will be given more representation than the previous composition of Council of Ministers.

For the second consecutive day, Jagan closeted with his advisor and party general secretary Sajjala Ramakrishna Reddy for nearly three hours to pick up his new team. "The exercise would go on till Sunday afternoon," Sajjala announced emerging out of the meeting. He said that those who are picked up for the Cabinet would get calls from the Chief Minister's office on Sunday

Giving the broad outline of the Cabinet composition, Sajjala said that those who resigned from the Cabinet would

also be part of the new team. "I cannot comment on how many of the old team would make it into the new Cabinet now. The Chief Minister knows very well how his team's composition should be and he would take the right decision," he said. Sources said at least seven ministers might be re-inducted into the new Cabinet.

As the team would take the government policies to the people in the run up to 2024 elections, the Chief Minister is said to have decided to

give more priority to BCs in the new team. 'BCs would be given more representation than the first Cabinet," he

said and added women would also be given priority. The first Cabinet of Jagan had seven BC ministers. It is said that the Home Minister post which was held by M Sucharitha in the first Cabinet would once again go to a woman.

The Chief Minister is said to have narrowed down on at least three leaders from each of the undivided 13 districts and exercise is on to pick up the final

#### Power crisis temporary: AP Energy Secy

URGING people to cooperate during the ongoing power crisis, Energy Secretary B Sreedhar said that the gap in demand and supply has led to an inevitable situation in the State where power holiday and other curbs had to be imposed on the industries so as to ensure supply to the domestic

and agriculture sector. Speaking to mediapersons on Saturday, the Energy Secretary maintained that this is a temporary situation, and added, We are expecting normalcy to be restored by the monthend, with demand for the agriculture sector dropping after the harvest season.

However, he said if the situation demands, there might be occasional one-hour power

cuts for the domestic sector over the next two-three weeks and assured the farm sector of seven hours of uninterrupted power supply during the day.

He further said, this summer economic activity has fully resumed after a gap of two years leading to a boom in the market.

Besides, the rise in mercury-level and the harvesting season have also added to it.

In Langer Houz, residents displayed polluted water in buckets and alleged that it is the same water that has been provided for the last few days in the colony. The residents complained that about 200 families residing in the colony and most of them are consuming polluted water leading to health hazards. They demanded that the government should look into the issue and

RENOWNED actor, director and producer Mannava Balayya died on Saturday morning due to age-related ailments in the city. He was 93 and is survived by his son and actor Tulasi Ram Prasad. He was honoured with the Raghupathi Venkaiah Award in 2010.

Born in Chavupadu village in Guntur district of Andhra Pradesh, Balayya was a Mechanical Engineering graduate. Inspired by stage plays and dramas, Balayya took to acting under the guidance of late director-writer Tapi Chanakva. who introduced him as the lead actor in the 1958 social drama Ettuku Pai Ettu. Produced by

continued to play the lead in films like Bhagyadevata and Kunkuma Rekha, which brought him recognition.

Balayya's Chivaraku Migiledi was described by actor Savitri as one of the most unforgettable films of her career. He acted as Krishna for the first time in the mythological film Krishnaprema and as Rukmangadhuni in *Mohini Rukman*gadha directed by KS Prakash Rao. Though Balayya continued to play the hero in several other films, he found great success in the supporting roles he acted alongside other actors.

The multi-faceted Balayya has acted in over 300 films and his last screen appearance as an actor was for Ramachari (2013), where he played the role of a Chief Minister.
