Telecom Regulatory Authority of India (TRAI)'s main objective is to see how the consumer can get cheap and beautiful but ever since it has taken interest in the cable industry, after every tariff order, prices have been going up intolerable and entertainment has gone down. Is going. There was a time when a family used to entertain the

whole family for Rs 250 or less, today a common family is deprived of this affordable entertainment. The President of Cable Operators Association of Gujarat Mr. Pramod Pandya has repeatedly submitted to the Telecom Regulatory Authority of India (TRAI) and the Ministry of Information & Broadcasting that no concrete action is being taken and the cable operators and the entertainment loving public are in trouble.
