Condolences to the bereaved families. May the injured recover soon. An ex-gratia of Rs 2 lakh from PMNRF would be given to the next of kin of each deceased. The injured would be given Rs 50,000," tweeted Prime Minister's Office. Bihar Chief Minister Nitish Kumar expressed his condolences to the families who lost their loved ones in a road accident in Vaishali. Kumar also gave instructions to



give ex-gratia grants to family members as per standard procedure and gave instructions for treatment of the injured, said Chief Minister's Office. At least seven children were dead and several others feared to be injured in a tragic road accident in the Meharn area of Vaishali, Bihar, said police on Sunday. The accident occurred after a truck rammed into a roadside settlement resulting in devastating consequences. Further details are awaited.

CV Ananda Bose to take oath as Governor on November 23

MI News Service, Kolkata: Former bureaucrat Dr CV Ananda Bose will take oath as the West Bengal Governor on November 23 in Kolkata, said officials. On November 17, President Droupadi Murmu appointed Bose as the Governor of West Bengal. "The President of India is pleased to appoint Dr C V Ananda Bose as regular Governor of West Bengal," read an official statement released by the Rashtrapati Bhavan on Thursday.

The post of the state's constitutional head fell vacant after Jagdeep Dhankhar was elected the country's Vice President on August 11. Later, Manipur Governor Ganesan was handed interim charge of the Trinamool Congress-ruled Bengal.

A 1977-batch (retired) Indian Administrative Service (IAS) officer of the Kerala cadre, Bose, now 71, last served as an ad-

ministrator in the National Museum in Kolkata before superannuating in 2011.

He has also served as the Secretary of the Government of India and Chief Secretary to State governments as well as University Vice-Chancellor.

Earlier while speaking on Friday, the newly appointed West Bengal governor opened up about his life while saying that he was looking forward to discharging his responsibilities as the constitutional head of the state.

"I consider this as a great opportunity for me to know the great state firsthand, to interact with the people and be of some service to the people of West Bengal," Bose said.

Bose, who will take over from Manipur Governor La Ganesan, who was handed interim charge of the state, said, "I don't see the governor's post as a big position but as an opportunity to commit my

service to the welfare of the people."

On the ongoing political climate in West Bengal, with the ruling Trinamool Congress facing Opposition attacks over the alleged teaching recruitment scam and the arrest of ministers and strongmen in connection with the recruitment scam and the alleged cattle smuggling case, the newly appointed Governor said, "Political situations are always fluid. (However) it's not an uphill task to function within the political system now prevailing in West Bengal. We have to face the political situation when it comes. We have to take appropriate action at the appropriate time and implement it in an effective manner." On incidents of political violence in the state, most recently after the last Assembly elections in 2021, Bose said, "that there have been more challenging, turmoil and violent situations in many

states in history, and India has passed through it."

"India is a strong Country and the people of India have the internal strength to face any situation. "We are an evolved democracy," Bose told.

On his views on the Bengal CM, Bose said, "I see Mamata Banerjee as a respected and elected chief minister. I certainly have an open mind and will work with her with objectivity."

"If the governor and the chief minister keep themselves within the confines of the Constitution, there will be no difficulty," he added.

On Mamata's frequent run-ins with former governor Dhankhar, Bose said, "The governor has to be concerned with Chief Minister Mamta Banerjee and not the politician Mamta Banerjee. These are two different aspects (of the relationship between a CM and governor)."

MI News Service, Kolkata: Mamata Banerjee administration is keen to improve citizen services. A pair of deputy mayors will be appointed this time to work better in Municipal area. In this regard, the Assembly passed the Municipal Amendment Bill. Municipal Minister Firhad Hakim presented the bill in the assembly on Monday. Despite uproar from the opposition, the bill was passed. Firhad Hakim said in response that it will be convenient to run the administration if there are two deputy mayors in the

municipal corporation. This bill makes that task much easier.

The West Bengal Municipal Corporation (Amendment) Bill, 2022 was presented by Firhad Hakim in the Legislative Assembly on Monday. The opposition started chanting. Speaker Biman Banerjee was annoyed by that. Addressing the leader of the opposition party, he said, "You tell your members to keep quiet. One says, others also say without listening to him. It can't go on like this." Still the chanting continued.

Later BJP MLAs walked out. The West Bengal Municipal Corporation (Amendment) Bill, 2022 was passed without a hitch.

What is in this bill? It is known that there is a proposal to increase the power of municipal administrators and officials in the revised bill. There is a proposal for appointment of executive rank officers in this post. They can take multiple decisions including financial decisions without depending on anyone. If the bill becomes a law, the mayor, deputy

mayors will be able to do multiple tasks including re-incorporation costs, recruitment, plan implementation. If the bill becomes a law, one more deputy mayor will sit in Bidhannagar, Siliguri, Chandannagar, Durgapur, Asansol Corporation.

The Bill will empower the creation of the post of Chairman-in-Council or CIC in all municipalities in the state. It is said that this decision is to speed up the work. The governor's signature will not prevent the bill from becoming law.

FIFA World Cup 2022: Football fever goes high in Kolkata, streets amp up with Messi posters

MI News Service, Kolkata: With the start of the FIFA World Cup 2022, football fever has gripped Kolkata as several parts of the city were decorated with flags of teams and posters of favourite players.

The Argentina Fan Club in Kolkata is decorated with flags and posters of Argentina and other countries participating in the World Cup. Giant screens are installed at various places in the city. Not to mention, the large cutouts and banners of Lionel Messi and Diego Maradona in the streets depict the enthusiasm of the soccer aficionados of the city.

"We are extremely positive this time. Argentina has an experienced team. Messi is playing really well. We are celebrating Football and FIFA World Cup. We will be watching matches on a giant screen and we have created a fan park here," Pragnan Shah, a member of Argentina Football Fan Club, Kolkata told.

The biggest extravaganza of football, FIFA World Cup 2022 started on November 20 in Qatar and will be held till December 18. Eight stadiums across Qatar will be hosting the 64 matches of this tournament.

A total of 32 teams from five confederations are competing at Qatar FIFA World Cup 2022 for the biggest prize in football. As many as 64 matches will be played during the

course of 29 days.

The teams are hosts Qatar, Ecuador, Senegal, the Netherlands, England, Iran, USA, Wales, Argentina, Saudi Arabia, Mexico, Poland, France, Australia, Denmark, Tunisia, Spain, Costa Rica, Germany, Japan, Belgium, Canada, Morocco, and Croatia, Brazil, Serbia, Switzerland, Cameroon, Portugal, Ghana, Uruguay and South Korea.

Notably, the 2022 FIFA World Cup tournament is the last with 32 participating teams, as the field will increase to 48 teams when Canada, Mexico and the United States will host the 2026 tournament.

France is the defending champion, having won their second title in 2018 after defeating Croatia in the final. French are aiming to defend their crown against a world-class competition offered by these aforementioned teams.

It is the final World Cup tournament for Lionel Messi, the Argentine striker considered one of the greatest ever footballers of all time. It is also highly likely that 37-year-old Cristiano Ronaldo will don the Portuguese colours for one final time.

This marks the first time the Middle East is hosting the event. It is also the first time the World Cup is being held outside the typical June-July window, in order to avoid the desert heat during the summers in Qatar.

Meanwhile, Enner Valencia scored a brace to help Ecuador defeat Qatar in the opening game of the 2022 FIFA World Cup at the Al Bayt Stadium in Al Khor, Qatar on Sunday.

With this win, Ecuador became the first team to beat the host nation in the opening match of the World Cup in the 92-year history of the tournament.

The Round of 16 from December 3 onwards will mark the beginning of the knockout stage of the tournament.

The quarterfinals will start from December 9 onwards, followed by the semifinals from December 14 onwards. The title clash will take place on December 18 at the Lusail Iconic Stadium in Lusail.

TMC office in RabindraBharati's Jorasanko campus should be demolished, orders HC

MI News Service, Kolkata: The Calcutta High Court has taken a strict stand against the Trinamool(TMC) party office in RabindraBharati University's JorasankoreThakurbari campus. The party office should be demolished. The heritage building should be restored to its original state. Heritage buildings should be identified separately. The Division Bench of the Chief Justice of Calcutta High Court gave such an order on Monday.

The authorities faced tough questions from the judge regarding the construction of party office in the university campus. Justice's question, even if it is not a heritage building, can someone build a party office anywhere? After that, he ordered to demolish the party office which was established in Thakurbari campus of RabindraBharati University. The Kolkata Municipality has to comply with the court order within the next 3 weeks. The next hearing of the case is on December 19.

The office of ShikshabandhuSamiti of the state ruling party Trinamool is being demol-

ished in the Jorasanko campus of RabindraBharati. A public interest case was filed in the court on this complaint. This order of the court is in view of that case. Petitioner lawyer Srijish Chakrabarty alleged that the office of Trinamool ShikshabandhuSamiti has been set up in the room where Rabindranath Tagore met Bankim Chandra Chattopadhyay for the first time in the Jorasanko house. But it is 'Grade One' heritage. The same incident happened in 3 campuses of the university.

Allegedly, there is not a single picture of Ravi Tagore, Bankimchandra Chatterjee in that room of Jorasanko. Pictures of state Chief Minister Mamata Banerjee, All India General Secretary of Trinamool are hung there. It is reported that two houses have already been demolished. Justice RajarshiBharadwaj and Justice Prakash Srivastava made it clear that the heritage building cannot be vandalized any more. Then on this day, the Division Bench of the Chief Justice gave a strict order.

Temp rise amidst nip in the air

MI News Service, Kolkata: The temperature rose slightly in the face of winter. The minimum temperature in Kolkata rose slightly to 19.2 degrees Celsius on Sunday. This temperature is normal. The weather office said that the temperature will remain the same for the next few days. Kolkata is likely to see a maximum temperature of 28.6 degrees Celsius on Sunday, which is 1 degree below normal. According to Alipore Meteorological Department, there is a distinct low pressure in South Bay of Bengal. It is affecting Bengal as well. The temperature mercury has been rising in Kolkata and surrounding areas for the past few days. The minimum temperature in the city was 18.1 degrees Celsius on Friday. On Saturday it increased slightly to 18.7 degrees Celsius. The temperature rose a little more on Sunday. However, although the mercury is rising, the temperature will start decreasing

soon, said the Meteorological Office. Temperatures will drop by several degrees by the middle of next week. Winter will again be felt in Kolkata and surrounding areas. Also, the temperature will decrease in other districts of West and South Bengal. According to weather office, there will be cloudy sky in Kolkata all day on Sunday. The maximum temperature may be around 29 degrees Celsius. Although low pressure is evident in the Bay of Bengal, there is no chance of rain in the state due to it, said the weather office.

Even though the temperature rises, Kolkata and surrounding areas are getting cold in the morning. It feels like winter. A thin sheet of fog is also seen here and there. The Meteorological Department said that as the western storm passes, strong winds will easily enter the state. As a result, it is not too late to start winter.

and some parts of her skull were recovered. Police also recovered two plastic bags from the couple's Mehrauli house.

Aaftab shifted belongings from his flat in Maharashtra's Palghar district to Delhi in 37 boxes in June and paid Rs 20,000 for it, a police official said on Monday. Poonawala had told Delhi Police that before moving to the national capital, he and Walkar fought about who would pay for shifting the items from their house in Vasai area of Palghar.

On Monday, a Delhi Police team went to the Bidhuri Dental Clinic in the national capital to seek a second opinion from the doctor on the jaw that was recovered recently. The police wanted to match the denture (which has been treated) with the jaw that was recovered at the Mehrauli forest, an ANI report said.

Delhi Police is also working on a theory suggesting Shradha was not strangled at all. Earlier, police said Aaftab was "high on marijuana" when he killed Shradha. They had been having fights regarding finances.

China Consul's assurance to protect the traditions of China Town

On Sunday morning, Chinese Consul General Cha Liu stood in the former Nanking restaurant square of Teritibazar and was surprised, "What did you say, Rabindranath Tagore came here! Raj Kapoor, Nargis also came. You know, I read about Nanking in books about Calcutta in China!"

Nanking is now known as 'Tung on Church'. Consul General Cha participated in a cultural tour of Kolkata's Chinese community with the stage 'Know Your Neighbor' to match the Satranga culture of Kolkata. In this Kolkata-darshan his achievements also overflowed. Kolkata is not just about Victoria Memorial or Saint Paul's Church. All the beautiful churches, mosques, synagogues or Chinese temples throughout the former gray town of the British period are also an identity of Kolkata. One also has to be impressed by the rugged appearance of the Chinese architectures, which have been designated as first-class heritage sites.
