Volunteers decide not to screen public for diseases until incentives released

DEMANDING payment of incentives that have been pending for several months, Women Health Volunteers (WHV) attached to the Makkalai Thedi Maruthuvamanai scheme have resolved not to screen new patients from Monday onwards. Makkalai Thedi Maruthuva Uliyar Sangam members have submitted a petition to the District Collector in this regard, and said they will continue to deliver medicines to the patients already identified.

The sangam members said in the petition that the State government had issued orders for providing incentives to the volunteers in Thoothukudi by September. "However the funds have not been released yet. We were recruited by the authorities for two hours of work per day. But, we are being forced to work the whole day. One month's salary is already pending and this work lacks job security," the petition read.

The Sangam secretary, Kohila, said the authorities initially asked them to screen 10 people daily, update their datum and deliver the medicines according to their needs. "However, with the officials now giving us a target to screen a minimum of 50 persons and update all information daily, we are overburdened now. This work eats up our whole day and that too for a meagre wage of ₹4,500 per month. The government had disbursed incentives to WHV in various parts of the State since April," Kohila said.

Ailing wild elephant dies without responding to treatment in Puliyangudi forest

Tenkasi: A 40-year-old ailing female elephant died in the Puliyangudi forest range on Monday. Foresters spotted some wild elephants trumpeting around an elephant lying on the ground near Vasudevanallur on Friday, and they alerted department officials. An official team led by forest range officer Karthikeyan called in veterinarians and chased away the other elephants before attempting to treat the ailing elephant. Not responding to veterinarians' efforts to feed it or make it stand, the animal died on Monday. District Forest Officer Murugan confirmed the death of the elephant. "The postmortem is over. Veterinarians suspect that the animal had developed severe infection in its stomach. However, we can confirm the cause of death only after we receive the postmortem report," he added.
