Hospitals struggle to care for wounded after Indonesia quake

Amid bed shortage, emergency workers race to treat injured in any outdoor space possible

SURROUNDED by chaos, panicked residents still filled the streets and hospitals of a West Javan town on Monday hours after a quake killed at least 162 people and injured hundreds.

Agus Azhari, 19, was with his mother in their family home when the living room was destroyed within seconds by the quake that was centred on West Java's Cianjur, the worst-hit town. Parts of the walls and roof fell to the floor, along with cupboards and other debris that hit his legs and hands.

"I couldn't see anything. The dust from the debris blocked my sight for a while," Azhari said. He said he had never experienced an earthquake like it before. The

roofs and walls of homes built on the town's hilly landscape. Many were made more vulnerable by the use of wood, mud and concrete in their construction. Emergency workers raced to treat victims in any outdoor space possible, with the town's three hospitals overwhelmed and not enough rooms to cope with an injury toll of 700.

At least 25 people were still trapped in the rubble, authorities said. Residents rushed lifeless bodies to Cianjur's Sayang hospital in pickup trucks and on motorbikes. Power outages meant doctors were unable to operate immediately.

Some of the injured sat on stretchers or blankets with their heads and limbs bandaged. Eld-

erly women sat in wheelchairs waiting to be treated as crowds of worried bystanders looked on. At another hospital, Cimacan, victims arrived covered in blood while parents looked for missing children.

Several injured elderly women were taken on stretchers into makeshift green tents erected outside the hospital.

People ran to resuscitate victims in the immediate aftermath of the quake, while others fled their homes for safety.

Dozens of aftershocks shook the town for minutes that, for rattled locals, seemed like hours. The province's governor said some of the injured needed their heads and feet stitched back together from wounds sustained by the debris falling around them.

Family members of Pak Army chief turned billionaires during his tenure?

Army chief Gen Qamar Javed Bajwa's family members and relatives became billionaires during his six-year tenure, making assets amounting to Rs 12.7 billion, a Pakistani website has claimed, prompting the government to order a probe on Monday into the "illegal and unwarranted" leak of their tax records.

The FactFocus website, which describes itself as a "Pakistan-based digital media news organisation working on data-based investigative news stories", shared the alleged wealth statements of Gen Bajwa and his family from 2013 to 2021 on its page.

According to the report regarding the alleged tax records of Gen Bajwa's family, the current market value of the known assets and business of the army chief, both within and outside

Pakistan, amounted to Rs 12.7 billion.

The report, released days ahead of Gen Bajwa's scheduled retirement later this month, claimed that the assets of Gen Bajwa's wife, Ayesha Amjad, went from zero in 2016 to Rs 2.2 billion in six years.

It stated the amount did not include residential plots, commercial plots and houses given by the Army to her husband. The report also alleged that

the total worth of the declared assets of Mahnoor Sabir (Gen Bajwa's daughter-in-law) jumped from zero in last week of October 2018 to Rs 1,271 million on November 2, 2018, while the assets of Mahnoor's sister Hamna Naseem went from zero in 2016 to billions by 2017.

Furthermore, the tax returns of Sabir Hameed the Army chief's son's father-in-law were less than a million in 2013 but in the coming years, he became a billionaire, the website claimed.

On Monday, Finance Minister Ishaq Dar ordered a probe after the tax and wealth details of Gen Bajwa's family members were released online by the website.

According to a statement, Dar took notice of the "illegal and unwarranted leakage of tax information of the family members of General Qamar Javed Bajwa".
