Irinjalakuda Christ College comes first in overall sports performance

CHRIST College, Irinjalakuda, has secured the first prize for overall performance in sports among the colleges under Calicut University in the academic year 2021-22.

St Thomas College, Thrissur, and Farook College secured the second and third prize, respectively. The colleges that secured the first three positions received ₹75,000, ₹50,000, and ₹25,000 cash prizes, respectively, during the sports convocation held at Calicut University on Monday.

'5,013 people live in extreme poverty in Thrissur' **EXPRESS NEWS SERVICE** @ Thrissur

AS part of the poverty eradication measures of the Central and state governments, a survey was conducted on March 2022 to identify people living in extreme poverty.

The survey found that a total of 5,013 people in Thrissur are living under extreme poverty. Of them, 3,636 are from grama panchayats, 996 from municipalities, 381 from the corporation, 1,337 belonging to Scheduled Tribe, and 44 from Scheduled Caste. Apart from them, 28 people were identified as migrant labourers, mentally challenged people and destitute.

The survey mainly focused on the health, living conditions and income of the people. Those who don't earn a daily income, destitute and families with bedridden or terminally-ill people were included in the extreme poverty category.

The Local Self-Government and Civil Supplies Departments also distributed Aaadhar cards, ration cards and voter ID cards to 750 people out of the identified extreme poverty cases. The state government aims to eradicate extreme poverty within four years. A followup survey will be conducted soon which will be jointly coordinated by the Local Self-Government and Civil Supplies Departments. "Necessary steps have been taken to ensure proper supply of nutritious food to people in the extreme poverty category.

"The decision will be implemented in the state from the next academic year. The school children will be made aware of all sports items under the new project," he added.

A six-member gang brutally manhandled a 38-yearold-man who questioned a cyclist who had banged his motorcycle. Sony Joseph, a resident of Perumpadappu, suffered a fractured leg and has been admitted to the Medical Trust Hospital, here.

The incident took place at Ooralakkasery Temple Road, near Palluruthy, on Sunday evening. According to police, the assault started when Sony's motorcycle was hit by a cyclist near the temple.

"When the cycle hit his motorcycle, Sony ques-tioned the cyclist. While they were arguing, another five persons stepped in and thrashed him.
