



Strictly implement ban on cockfights: Collector Shukla

DISTRICT Collector Krithika Shukla ordered the officials for strict implementation of ban on cockfights and other gambling sports on the occasion of Sankranti festival.

She held a review meeting with police, revenue, veterinary, panchayat and transport officials at the Collectorate here on Wednesday.

The Collector informed that the High Court issued orders for banning cockfights during the Sankranti season. She wanted traditional rural sports to be motivated and encouraged and instructed the officials to create awareness among the people to celebrate Sankranti festival in a traditional joyful manner.

Krithika warned the organisers of stringent action if they conduct cockfights. She wanted to constitute committees and monitor the situation. She advised them to utilise propaganda material against cockfights such as posters, banners in the district. She also wanted them to propagate the rules regarding the action to be taken against cockfights. She stated that action will be

taken against the owners of agricultural fields or private lands where cockfights will be held.

The Collector suggested providing an alternative by holding competitions pertaining to rangoli, volleyball and other traditional games. She also asked them to create an awareness regarding the traditional games. The officials were instructed to strictly follow High Court orders in toto. She instructed them to set up check-posts near the borders of the districts and prevent the people with any intention to indulge in

cockfights. The officials further directed to stop people coming from other districts carrying bags of money along with them for participating in the cockfights. She wanted the officials to hold meetings at division and mandal levels and take necessary steps for preventing cockfights as well as gambling games.

She also wanted a comprehensive report regarding the supervision, action and allied disciplinary action taken against those who are responsible for cockfights.

CPI stages protest over ban on roadshows

Cyclone-hit tobacco farmers to get relief

TOBACCO Board Executive Director A Sridhar Babu informed that Mandous Cyclone had affected tobacco crop in 26,197 hectares in southern region of AP and necessitated the farmers to go for replantation. Addressing the media at Tobacco Board office here on Wednesday, he said that considering the plight of tobacco farm-

ers, the Government of India approved to extend an interest-free loan of Rs 10,000 to each tobacco grower. Sridhar Babu said financial assistance in the form of interest-free loans will be a great immediate relief to the farmers in distress. He said out of 53,500 hectares in southern region of AP, crop was affected in 26,197 hectares. Tobacco exports during 2021-22 were 2.25 lakh MTs worth Rs 6,880.21 crore, he added.

PPOs presented to 101 secondary family pensioners

THE Vijayawada Division of South-Central Railway organised secondary family pension-mega payment order (PPO) mela at Railway Auditorium here on Wednesday to distribute PPOs of secondary family pension to the unmarried, widow, divorced daughters, mentally and physically disabled wards of the deceased railway employees in the past two years.

Divisional Railway Manager Shivendra Mohan was the chief guest while ADRM D Srinivasa Rao and CPO P Kishore Babu were guests of honour.

Addressing the media, Shivendra Mohan stated that it is a landmark day in the history of Vijayawada Division where 101 PPOs are being handed over to genuine and eligible secondary family pensioners of the deceased railway employees of the Division at one go. He said the world was reeling under Covid pandemic for the past two years, which inevitably led to rise in pending cases, numerous representations from family members of the deceased Railway employees. He thanked the officials of Accounts and Per-

sonnel Department in Headquarters for issuing a joint procedure order and simplifying the procedure to establish the veracity and eligibility of the credentials submitted by the beneficiaries for availing PPOs.

ADRM D Srinivasa Rao said that Vijayawada Division always led by example in serving its employees and family members with dedicated efforts.

CPO P Kishore Babu stated that once a railway man is always a railway man. He also said that hard work and commitment of the employees will never go in vain and shall be bestowed back to their family members in the form of pension during their troubled times.

Later, Shivendra Mohan distributed secondary family pension PPOs to 101 eligible dependents. Out of 101 secondary family pensioners, 53 were unmarried daughters, two Divyang Jan wards, 32 widowed daughters and 13 were divorced daughters.
