Nagji Desai, president of Pashupalan Bachao Samiti, said the AMC must issue licences to cattle owners and let them keep their cattle in the courtyards of their houses. According to the new policy against stray cattle, only cattle owners who have exclusive space for cattle will get licences.

6 in 10 Residents in Delhi - Mumbai might consider relocating due to Poor Air Quality

Ahmedabad, A new study from healthcare provider Pristyn Care found that nearly 60% of people in Delhi and Mumbai are considering relocating because of worsening air quality and pollution. Both cities deal with high pollution every year, and there's still no permanent solution for this recurring problem. The study included 4000 people from Delhi, Mumbai, and nearby areas.

A staggering 9 in 10 respondents report experiencing the most common symptoms of the deteriorating Air Quality Index (AQI). These include persistent coughing, shortness of breath, wheezing, sore throat, and watery or itchy eyes. These findings highlight the profound impact of declining air quality on the well-being of individuals, especially during the winter season. In fact, 40% of respondents have also observed a deterioration in pre-existing respiratory issues such as asthma or bronchitis among their loved ones during the winter season. The study also revealed that 4 in 10 residents in Delhi and Mumbai seek medical attention for health issues related to air pollution every year or at least every few years. When questioned about adjusting their lifestyle to deal with air pollution, 35% mentioned they stopped outdoor activities such as exercising and running, while 30% began wearing masks outdoors. 123 on vidya sahayak list to choose locations

Ahmedabad: The state education department has called 123 candidates on the waiting list to select their preferred locations for the appointment of vidya sahayak in primary schools. The candidates will remain present for district selection on November 28. The department has appointed 2,600 vidya sahayaks in the state's primary schools; however, 123 positions had remained vacant. These vacancies will be filled with the wait-listed candidates. The district selection process for the 2,600 candidates already selected has been completed. The education department had issued call letters to these candidates on November 21 and asked them to remain present on Tuesday. The UPSSSC has released the final selection list for the UP Rajasva Lekhalp Main Exam 2022. Candidates can check their selection status on the official website.

The examination was conducted on July 31, 2023. The Commission aims to fill 8085 posts of Rajasva Lekhalp in the UP Board of Revenue, Lucknow. Candidates can follow the step-by-step process to check and download the final selection list. The Union Public Service Commission has released the written results for UPSC NDA, NA II 2023. Candidates who participated in the National Defence Academy and Naval Academy Examination (II), 2023 can check and download the written results.
