The medical superintendent (MS) of AIIMS Rishikesh, Dr R B Kalia said that all the 41 labourers have been given clearance by the hospital administration and 40 have been discharged from the hospital. Dr Kalia said that all the labourers are physically normal and clinically stable. He said that the AIIMS Rishikesh has given clearance to all the labourers and they can now go to their houses.

The MS said that apart from the changes noticed in the people who work in the higher Himalayas all the workers informed that the incident can induce some mental changes in the labourers and for this they have been advised to take medical advice from the nearest medical centre after two weeks.

Dr Narendra Kumar of AIIMS hospital administra-tion said that most of the labourers have left the hospital for their homes. He said that the hospital administration is in touch with the nodal officers of different states and is discharging them as per their

### Dhami's triumph

Chief minister Pushkar Singh Dhami has emerged politi-cally stronger and administratively powerful after the suc-cess of the mission Silkyara. After the initial chaos in the operation to save the lives of the trapped labourers in the tunnel in Uttarkashi district, the CM himself took the command of the operation in his hands and effectively managed the situation and steered it till it ended in the successful evacuation of the trapped workers after 17 days. He regularly visited the mishap site and camped in Uttarkashi for three days to boost the morale of the rescue workers. Showing sensitivity and deep empathy for the trapped workers and their families, the CM cancelled the Igas celebration and concentrated himself on mobilising resources, coordinating with the Union government and motivating the officers/workers engaged in the rescue operation. By holding the Igas celebration after the rescue of the workers at his residence and inviting the evacuated workers, their families and rescue team members, Dhami has won the hearts of even his detractors. The failure of the operation would have given the State a bad name and would have given an opportunity for Dhami's opponents both inside his party and outside to question his leadership qualities.

### Dealing disaster

A mid the euphoria generated by the success of the mission Carried out to save the lives of 41 labourers stranded in the under-construction tunnel in Silkyara, one should not forget to ponder over the point that the State needs to further strengthen its disaster management and mitigation system. Natural disasters occur with glaring regularity in Uttarakhand and considering this, the State became the first in the country to create a separate department to deal with disasters. But the red tape and careless attitude of the babudom of the State has rendered it almost ineffective. The Uttarakhand Disaster Management Authority (USDMA)- set up with the objective of being a nodal agency for planning, coordination and monitoring activities related to disaster prevention, mitigation and management- is suffering due to rampant ad-hocism. USDMA has 333 sanctioned posts but most of these are either vacant or are being manned by contractual staff. Interestingly, after every disaster, the demand for a full- time minister to head the disaster management department surfaces but nothing has yet been done to address it. At present, the department is under the chief minister who also holds 28 other portfolios.

#### Changing Address

Probably perturbed by frequent traffic jams on the roads of the provisional State capital, the Congress stalwart Harish Rawat has moved to a new house in Dehradun. His new address is now Defence Colony where he has become neighbour of fellow former CMs- Bhagat Singh Koshyari, Trivendra Singh Rawat and Vijay Bahuguna. Located near the Haridwar Road, Defence Colony is said to be ideal for Rawat. Apart from saying travel time -his earlier rented accommodation was in

## U'khand reports rise in dowry & mental harassment cases against women

In a worrying trend, cases of dowry and mental harassment cases in the State. Such ment against women across the State have shown a spike over the past few years despite various measures taken to strengthen women's safety.

As per the data shared by the Uttarakhand Commission for Women (USCW), Dehradun has recorded the highest number of domestic violence cases among the districts of the State-177 in 2022-23. Haridwar has recorded 31 domestic violence cases while Udham Singh Nagar has recorded six such cases. Further, Dehradun has witnessed 60 dowry-related cases while the figures for Haridwar and Udham Singh Nagar districts are 45 and six respectively

Commenting on the rise in harassment cases involving women across the State, the USCW chairperson Kusum Kandwal said, "Based on the commission's findings, Dehradun, Haridwar and Udham Singh Nagar figure

ment cases in the State. Such cases have been rising across the State over the years, but we are particularly concerned with the figures of the three dis-tricts," she said. "One of the main reasons for this surge is the increased women's rights awareness. Women have now gathered courage to speak up against wrongdoing or harass-ment they face," she said.

She further said that if a woman encounters any form of harassment in the State, she can seek assistance from the commission. "To lodge complaints, women can send direct messages via WhatsApp to the commission's designated number at 812677474. Upon reviewing the complaint, the commission provides counselling to all the parties involved in each case. If the individual or the family is found to continue harassing women even after the counselling session, the commission conducts follow-up procedures and takes strict actions," she

# Broken piece of headlight helps police to nab killer of duo

The police have arrest-ed the accused responsible for the death of the duo whose bodies were found in Dehradun's Vasant Vihar area on November 26. The woman and the man had fallen into the canal and on the roadside respectively after being hit by the accused's vehicle. After the accident he pulled the

man's body and put it near the woman. The police have arrested the accused who has claimed that he accidentally hit the duo Sandeep Mohan Dhasmana (40) and Hemlata (37) as the left headlight of his vehicle was damaged, said the Dehradun senior superintendent of police Ajai Singh. He said that the post-mortem report of both deceased had revealed that they died due to internal injuries, which is pos-



sible after getting hit by a heavy object and the police suspected it to be a hit-and-run case. The accused Sharukh (23), a resident of Uttar Pradesh's Saharanpur, confessed that he could not see both victims clearly on Sunday around 5:30 AM as the left headlight of his vehicle was also damaged due to which he hit the duo. After the woman fell near the canal and the man on the roadside, he pulled his

body near the woman to ensure people did not observe them and called the police. Singh said that the police analysed 150 cameras to identify the vehicle. He said, 'We got only a broken piece of headlight from near the body as a clue. We

sent it to different companies to identify which company's vehicle it belongs to. One of the companies identified it after which we started looking for the vehicle of that certain company via CCTV footage of the incident site. We finally identified the accused who confessed that he accidentally hit the victims from behind after he was returning from selling milk in the Vasant
