## Electors rush to hometowns to cast vote

They struggled during the morning hours while boarding buses owing to the failure of TSRTC to make proper arrangements. This was witnessed in the MGBS bus station during morning hours.

## Many voters complain about their names missing from list

- Despite inclusion in recent surveys, voters faced missing names
- Some voters found their names in multiple booths unexpectedly

VOTERS complained that their names were missing from the voter list in Secunderabad Cantonment, Secunderabad, and Musheerabad constituencies in the State Assembly elections held on Thursday.


In Musheerabad, around 80 voter names were missing, in Secunderabad constituency and Secunderabad Cantonment, around 30 to 40 names were missing from the voter list. The same scenario was witnessed at Amberpet, and many people returned without voting. Despite the special drive conducted in all the constituencies that allowed voters to add their names back to the electoral rolls and provided them with new EPIC cards, many names went missing. Interestingly, the names of a few voters from Old Dairy Farm, Secunderabad constituency, were found in two booths at the same polling station.

According to a few voters from Musheerabad constituency, many voters were seen frantically running around various polling stations, trying to locate their names, only to discover that their names were missing from the list.

"I was surprised to see my name missing from the list because names were recently included in the most recent survey, but I did not receive the card. My vote has now vanished from the rolls," said Shaheen Begum, Tarnaka, Secunderabad constituency resident.

"I was excited because it was my first time voting, but when I inquired today, I discovered that my name was not on the list. I recently registered my name through the enrollment drive, but my name still vanished from the list," said Rashmi Rao, a resident of Secunderabad Cantonment constituency.

"I have been voting for several years, but this year my name disappeared from the list, so I was forced to check in at all the polling booths in Amberpet constituency, as I did not receive voting slips. How is it possible when I included our names in a recent survey and all my family members' names were there but not mine?" said Rakesh Reddy, a senior citizen from Amberpet.



## Confusion over polling stations leave city voters high and dry

- Voters were disappointed to see their name missing from electoral roll
- Electors criticise the relevant authorities for failing to provide voter slips
- Express dismay at police scrutiny over voters for not carrying EPIC cards

VOTERS at several polling stations under Musheerabad and Amberpet Assembly constituencies were found returning without casting their votes. The reason is they could not figure out their polling stations. Speaking to The Hans India, L Naveen Reddy from Amberpet said, "My name was not there in the polling station where I cast my vote earlier. The mobile app for locating his polling station has time and again flashing 'No Results'".

He said election officials from GHMC used to come home and hand over the voter slips in the last Assembly and Lok Sabha elections. It made it easier for the voters to directly reach their polling stations and cast their votes.

Voicing the same and explaining the problems faced, V N Sastry from Chikkadapally said that big flexes were put up at the polling stations, indicating assistance was available for the voters. But, except for the men from different parties with tables using the voter slips, there are virtually none visible to help out and guide the voters where they could get their voter slips to cast their votes.


"When I called the BLO on a given number, he simply said the polling station number and asked to go and search behind the fever hospital. But, only to be told that I had come to the wrong polling booth after going there."

The voters without voter Identity cards carrying the Aadhar and other valid documents have expressed dismay at police scrutinising them and asked multiple questions at the entry points.

C Deepak, a graduate student said that the police who stopped him were so dumb that they did not know that even the Election Commission had listed several documents like Aadhaar as valid for people to cast their vote.

"They were giving a standard reply that they have not got 'any instructions'. When I further pressed, the constable on duty showed a police official and asked me to go and ask him."

Is it election officials concerned, or do police decide on the validity and invalidity of the documents and process of people to vote? He found fault with the EC and its machinery for all such problems faced by the people in the polling stations that resulted in people returning without voting.
