## NEET aspirant dies by suicide in Kota, 26th case this year

ANOTHER STUDENT preparing for the National Eligibility-cum-Entrance Test (NEET) in Rajasthan's Kota district allegedly died by suicide by hanging herself from a ceiling fan in her hostel room, police said on Thursday. This is the 26th case of suicide by a coaching student in Kota this year.

Nisha Ahir (22), a resident of Uttar Pradesh, allegedly hanged herself from the ceiling fan of her hostel room on Wednesday night, said Assistant Sub-Inspector (ASI) Kundan Kumar of Jawahar Nagar police station.

The ASI said that no suicide note was found from the student's room.

The actual reason will be known after her family members reach here and what the postmortem report say, he added.

District Collector Mahavir Prasad Meena said the administration has held a meeting with the coaching institutes and hostel operators instructing them to take steps to prevent recurrence of such incidents.

West Bengal resident Faureed Hussain, who was preparing for NEET, had allegedly committed suicide by hanging himself on Monday.

# Cong sure to win in Rajasthan, BJP to lose in all 5 states: CM

**CHIEF MINISTER Ashok Gehlot** on Thursday said he was confident of a Congress win in Rajasthan Assembly polls, and added that the BJP would not form the government in any of the five states where elections are being held.

Five state went to polls in November. While polling in Telangana ended Thursday evening, it was held earlier in the month in Mizoram, Chhattisgarh, Madhya Pradesh and Raiasthan. Results of the elections will be

Minister Narendra Modi, Union Home Minister Amit Shah, during the election campaign. "It was the language of vengeance and creating tension," he said.

"No one liked the language they spoke. They were attacking me because they could not topple my government like they did in Andhra Pradesh, Karnataka and Madhya Pradesh. They failed. They were hiding that pain inside. They deliberately planned in Delhi to not let Congress retain its government in Rajasthan. So, they were angry and spoke such a language," he said.

Replying to a question on a UP court issuing summons to Congress leader Rahul Gandhi for "objectionable" remarks he

made on Home Minister Amit Shah in 2018, Gehlot said, "The attack on Rahul Gandhi will cost them in 2024. The aura of Modi ii is not the same as it was earlier. People do not come to his public meetings like earlier. He is not able to understand it."

He further said, "His (Rahul Gandhi) membership is not going to be affected. They keep hatching conspiracies. I cannot comment about it. These people are conspirators. They are destroying the country. killing democracy and the constitution."

The CM added that the judiciary is working under pressure, and that the credibility of investigating agencies like ED, I-T and CBI is being destroyed.

in the outcome for Rajasthan, while predicting that Mizoram could be headed for a hung Assembly.

In a major setback for the K Chandrasekhar Rao-led BRS, which has been in power in Telangana since the formation of the state in 2014, all the exit polls predicted a Congress sweep. They differed only on the scale of the Congress victory.

If the exit polls turn out to be true, it will be a huge morale booster for the Congress in southern India, months ahead of Lok Sabha elections. The party had ousted the BJP from power

in Karnataka earlier this year. BRS working president K T Rama Rao, son of Chief Minister K Chandrasekhar Rao, dismissed the exit poll results, which were announced hours after polling concluded in the state. "I promise you, for those of you who are friends of BRS and want KCR to come back from the state. I promise you on December 3 we are coming back. We are coming back anywhere between 70+ seats (out of the total 119 segments)," he told reporters.

For Chhattisgarh, almost all the polls predicted a clear edge for the Congress, although not a sweep. The Congress was a divided house in Chhattisgarh till some time ago but it tried to paper over the differences by elevating state minister T S Singh Deo, the main challenger to Chief Minister Bhupesh Baghel, as the Deputy Chief Minister in June this year. The BIP, on the other hand, went into the election

without a clear face. While the party had won 68 seats in the 90-member House in 2018, the polls suggested that it could retain the state but with a lesser number of seats this time. Baghel, however, stuck to his party's claim that it will win 75 out of the 90 seats. When asked by reporters about a survey giving it 57 seats, he said, "That 57 will be interchanged to 75."

On whether he anticipates poaching attempts by the BJP, the Chief Minister said, "There will be no need for it and they will not something, surveys might sugbe able to do it. We believe in our gest something, but based on the hard work and have faith in the public."

In Madhya Pradesh, most of the polls gave an edge to the ruling BJP while one poll projected a Congress victory.

### Amid protests over post on Prophet, offline classes for colleges suspended

WITH PROTESTS over an alleged social media post on the Prophet by a student from outside Kashmir simmering, Srinagar's National Institute of Technology (NIT) has announced winter vacations and asked students to vacate the hostels. The state government has also suspended offline classes in the Valley's colleges and directed the college administrations to switch to online classes.

It has also issued an order prohibiting "posting, uploading or propagating by way of forwarding or sharing" any message or content that promotes "ill will on religious grounds" and is likely to disturb public order, tranquility.

According to the police, a case under IPC sections 153 and 295 has already been filed against the NIT student, based on a complaint by the Registrar. Protesting students are, however, demanding his arrest.

"Pursuant to declaration of winter vacation for students from November 30, all hostel boarders (boys and girls) are instructed to vacate the hostels

with immediate effect," NIT's Dean of Students Welfare stated in an order.

An official said directions in this regard had come from the

state government. On Thursday evening, J&K's higher education department also ordered the suspension of offline classes in colleges from December 1 to 31. While the government has said this has been done because of the weather, sources said authorities want to ensure protests over the issue don't spread.

Ripples of the alleged incident have already been felt at Srinagar's Amar Singh College, where students took out a march on Wednesday, as well as at Islamia College of Science and Commerce in downtown Srinagar.

"Due to early onset of winter, students enrolled in Government Degree Colleges of Kashmir Division are facing major challenge in commuting to college and, thereby, attending classes. Situation has got compounded due to disruption to normal class work with inadequate heating arrangements," reads the government

order. "In order to ensure unhin-

dered academic delivery in adverse and extreme cold conditions, it is impressed upon all the Principals of Government Degree Colleges of Kashmir Division that classes will be conducted via online mode from December 1 till December 31, or till winter vacations are announced, whichever is earlier,"

it states. The faculty have, however, have been asked to attend college regularly.

In an order, Deputy Commissioner Kupwara Ayushi Sudan said that some "anti-national persons or groups are resorting to misuse of social media networking platforms on internet by 'preparing' or 'posting' or 'uploading' or propagating by way of 'forwarding' or 'sharing' incendiary messages and propaganda of terrorist and separatist outfits". The order states that under section 144, any such social media activity is prohibited with immediate effect.

Police have also registered a separate FIR after a complaint from a woman student of NIT, who alleged that her pictures with the student accused of the social media post were being spread online alongside abusive comments.
