People contributed to bridge collapse: Oreva MD to HC

Ahmedabad: Seeking regular bail in the Morbi suspension bridge collapse case, Oreva Group MD Jaysukh Patel submitted before the Gujarat high court that there is a feeling of remorse and indirect guilt, but blamed people for their contributory negligence by swinging the bridge.

His counsel Nirupam Nanavati submitted that there is total lack on mens rea on Patel's part, and the maximum that can be attributed to him is negligence.

Patel cannot be placed behind bars till the end of the trial, for he is not facing a charge entailing life imprisonment or death sentence and his custody would not help anybody, the advocate said.

The lawyer further submitted that there is a feeling of "remorse, of indirect quilt, and responsibility", but also pointed out the heavy rush of people on the bridge during Diwali and talked about their negligence. "Going by the chargesheet, it is stated that more than 200-300 people were on the bridge. I was not present, but ticket vending staff, my employees somehow either permitted or because of holiday people made a rush to the bridge beyond the strength of the bridge. And they swung the bridge also, and then it collapsed. So, it is an intervening factor in my humble submission, which has contributed to the collapse. It is like contributory negligence in other words as it is considered in motor accident cases." The bridge collapsed on

October 30, 2022, resulting in the death of 135 people. The bridge was thrown open four days before this incident after purported repairs and renovation. Along with Patel and Oreva employees, owners of the engineering firm that repaired the bridge are also accused in the case.
