# Civic body to use single-use plastic waste to lay road in Belagavi city

The 90-metre-long, 10-metre-wide road will be built in front of its Ashok Nagar office

THE Belagavi City Corporation (BCC) has come up with a unique project to eliminate the single-use plastic waste from the garbage. This project, said to be the first in the state, BCC is gearing up to use the plastic waste in constructing roads in Belagavi city.

As a trial project, the BCC has planned to build a 90-metrelong and 10-metre-wide road in front of its office at Ashok Nagar in Belagavi. The PWD standing committee, in its recent meeting, has already given approval for this project and is waiting for the issue of work order.

Once this trial project is sucthis plastic, he said.

cessful, the BCC may think of adopting this method for the construction of other roads in the future so that they can recycle the single-use plastic in a better way.

#### How is plastic used in road construction?

P N Parashuram, Assistant Executive Engineer (AEE) of PWD section, BCC, who is M.Tech in highway constructions, said that the use of plastic waste in constructing roads had been introduced in Indore. There were many research papers presented on this concept. Single-use plastic bags of thickness below 80 microns are banned. It is difficult to recycle

"The BCC has seized 5 tonnes of single-use plastic in Belagavi. Out of this, we plan to use 250 kg plastic which has been cut into shreds using a shredding machine. In the trial project, we will be using 1,700 kg bitumen and 250 kg plastic to construct a 90-metre road. The ratio of plastic used in the bitumen is around 6% to 8%. By using this plastic, the durability of the road will be increased to a minimum of 10 years which is almost double compared to roads made only out of bitumen. This will not cause any harm to the environment," he explained.

Vani Joshi, chairman, Town Planning and PWD Standing Committee, BCC, said, "We

have discussed in detail about implementing this trial project in the recent committee meeting. Tonnes of single-use plastic waste is generated in the city limits every year. Once this project is successful, we can use the plastic waste in making new roads."

Ashok Dudagunti, BCC Commissioner, said that the main objective is to keep the city clean, green and make the best use of waste. "We have seized about 5 tonnes of banned single-use plastic from the market. This will be used in a meaningful way to make roads and will provide solution for the use of plastic waste in the future. We are the only city in Karnataka to adopt this concept," he said.


