THE residents of Peermade and Murinjapuzha villages are living in fear due to the recurring presence of tigers in the region. However, in the inspection held under the leadership of forest officials from the Murinjapuzha and Peermade ranges, they could not confirm the presence of the big cat. They were un-

deputy range officer "In Thottapura, a government official had spotted the tiger. Since Thottapura lies close to the forest area, the tiger might have strayed into human habitation from the nearby forest," he said.

Since there was no attack on cattle or any untoward incidents reported in the area, the department has not initiated any action to capture the big cat. "However, patrolling is be-

ing conducted at locations where the residents have spotted the tiger," he said. Last week, after a tiger cub was found dead on the highway near Murinjapuzha, the employees of a KSRTC bus reportedly spotted a tiger on the national highway. Sunil said, the dead animal was not a tiger cub, but a leopard cat, that might have been accidentally killed after it was hit by some vehicle while

trying to cross the road. Earlier, three passengers had also spotted a tiger on the

National Highway when they were heading to Vandiperiyar.

The inspection conducted by the forest department had identified pug marks and confirmed it was a tiger. Sunil said that though there is a long distance between the National Highway and the forest area by road, there is only a

4km aerial dis-

tance between the road and the reserve

"Residential areas, except estate lane houses, are few in between them. The location comprises mainly of plantation where wild animals like sambar deer are frequently spotted. Hence, there are chances for the tiger to stray into the highway through the estates," he said.

Thrissur: The Sea Rescue team under the fisheries department on Wednesday rescued five fishermen who were stranded in the mid-sea after the engine of the St Antony's boat malfunctioned. The fisheries department received the help call around 2pm on Tuesday. Though the team set out with the boat for rescue, they returned around 3am on Wednesday as the faulty boat was brought to the shore after tying it to the rescue boat.
