#### Leopard spotted near Srisailam ORR

A leopard spotted on the outer ring road in the early hours of Sunday had scared the residents of Srisailam town. It was seen sitting on a wall near Ratnananda Swamy Homa Gundam. After a while, it returned into the thick forest.

The residents and devotees after spotting the wild cat were gripped in fear. Some tried to capture the wild animal in their mobiles, but could not get a clear picture due to thick fog.

It was learnt that the big cat was also spotted on Saturday night near the outskirts of Srisailam temple. Two days ago, on Friday the leopard has ventured into residential area.

A source has stated that the leopard entered into SC colony, which is adjacent to the outer ring road. The source also stated that for the last three years, the number of leopards drastically increased and they are frequently venturing into the residential areas in search of food.

It should be noted that a leopard was spotted three months ago on the same outer ring road at Rudra park. Then residents brought the issue to the notice of the forest department officials. The officials set up trap cameras to capture the movements of the wild beasts.

AS part of the initiative to maintain law and order problem on New Year Day, SP Dr K Tirumaleswara Reddy conducted surprise inspections along with special enforcement bureau officials on Chennai - Kolkata national highway during late hours of Sunday. He conducted night patrolling from Venkatachalam Toll Plaza to Manubolu.

During the flash raids, the

SP has seized illicit liquor being transported in a car at Venkatachalam Toll Plaza and ordered for taking legal action on the culprits. He secured the details of the suspected persons including their finger prints travelling in buses and cars. They were also ordered to conduct special drive over triple riding on motorcycles, driving vehicles in inebriated condition, minors driving vehicles, cell phone driving, driving vehicles with defective numbers etc. He urged the people to inform the police immediately, if they notice anti-social activities at their respective areas by dialling 112 or nearby police stations.

successful launch of the rocket, which is scheduled to be launched at 9:10 am on Monday from Sriharikota launch pad. The PSLV-C58 will carry two scientific payloads into a low earth orbit at an altitude approximately 650 km. The satellite will be placed in a circular low earth orbit of 500-700 km, with a mission lifespan of at least five years.
