

Trichy councillors seek eviction of street vendors from arterial roads

Encroachments Lead To Traffic Congestion

Trichy: Expressing concerns over street vendors encroaching major roads, Trichy corporation councillors in the council meeting on Wednesday sought the local body to streamline street vendors to prevent traffic bottlenecks. A section of councillors urged the authorities to regulate the mobile eateries functioning during the night as they don't contribute to the local body's revenue but occupy arterial roads and junctions.

Councillor P Senthilnathan (ward 47) said a woman riding a two-wheeler on Pudukottai Main Road near Kallukuzhi bridge lost her life in a road accident last week caused due to encroachments by

vendors. "When corporation employees try to remove encroachments, there is no support from police. Outlets are illegally occupying the walking tracks around the Anna stadium at Khajamalai too.'

Two cops suspended after visiting BJP's enrolment camp

Trichy: Two policemen attached to the Velippalayam station in Nagapattinam district were placed under suspension on Wednesday on charges of violating service

The action comes days after the two policemen deployed for bandobust duty at BJP state president K Annamalai's padayatra in Nagapattinam, visited the saffron party's membership enrolment camp set up at the place wearing their service uni-

Police officials said the two had allegedly enrolled themselves in the party on the day, which was a violation of 18(1) of the Tamil Nadu Subordinate Police Officers Conduct Rules 1964. Deputy Inspector General (DIG) of Thanjavur range T Jayachandran issued the suspen-

The action comes days after the two policemen visited the saffron party's membership enrolment camp set up at the place wearing their service uniform

The incident happened on December 27 evening, when Annamalai visited Nagapattinam to participate in the 'En Mann En Makkal' yatra. In a video widely circulated on social media, sub-inspector K Rajendran and special sub-inspector A Karthiwho were on bandobust duty at Avurithidal area on that day, are seen approaching the BJP's membership enrolment camp at Avurithidal enquiring some-

thing with the volunteers. Based on the video, SP Harsh Singh ordered a DSP to inquire into the incident. During the inquiry, the two

missed call at the BJP enrolment camp to join the party. However, they refused to surrender their mobile phones for verification.

The inquiry report was sent to the DIG of Thanjavur range for further action on December 29, said SP Singh told TOI. They were transferred to armed reserve police on the day.

Singh said that the two policemen had given their mobile phone to BJP volunteers at the enrolment camp and received it back after a

The official order from the Thanjavur range has stated that it was a gross misconduct for having tried to join as a member in a political party, in violation of the rules.

Meanwhile, Annamalai condemned the suspension and demanded the state government to revoke the order.

Trichy: Three incidents of chain and bag snatchings wererecorded in the last one week in Trichy city.

M Sundaram, 63, from Kallar street in Periya Milaguparai was walking on the road near KAP Viswanatham Government Medical College (KAPVGMC) around 9pm on Tuesday, when two men on a bike snatched his mobile phone and fled

On December 28, M Pushpalatha, 44, of LIC colony in KK Nagar was riding her bike near Cloud Nine church on Sathanur Road at around 7pm, when two unidentified

people on a bike grabbed her five sovereign gold chain. She managed to catch hold of 2.5 sovereigns of the chain while the snatchers fled the scene with the broken part.

On December 30, two bikeborne snatchers targeted Nagarathinam, 58, of Viswas Nagar on Thanjavur Road. She was riding pillion with her brother near the Manjathidal railway station when the duo tried to snatch her bag. Nagarathinam lost control and fell on the road and suffered head injuries and was admitted to a hospital.

8,000 students get dates syrup to prevent iron deficiency

Rail restaurant to come up in Trichy

Trichy: The Trichy railway division will soon launch a restaurant on a coach within the premise of the railway museum located in the city. Following Chennai, the authorities have taken this initiative to provide dining experience to rail passengers and the public. A private company will set up the restaurant and run it for a period of five years at a licence fee of ₹15 lakh, officials said. To station the coach, a concrete base was laid to a length of 30m. The process of laying a broad gauge track is now in progress.

"Kitchen will not be on the coach. Dining will also

be arranged out of the coach based on the demand. We expect the work to be completed by the mid of March" a senior official from the commercial department said.

After five years, the agency will hand over the coach to the railways. There is also a plan to provide a parking space inside the museum premises for the public coming to the restaurant.

Man dies in hit-and-run incident

Trichy: A 68-year-old man died after he was hit by an unidentified vehicle at Oottathur in Trichy on Tuesday.

Police said S Mudiyappar of Keelavaladi in Lalgudi taluk was walking on the side of a road near Perumal temple on Tuesday morning when the unidentified vehicle hit him. He suffered severe head injuries and died on the spot, said a police officer.

The Kanakiniyanallur police filed a case and took up the investigation based on a complaint from Mudiyappar's daughter D Lourde Mary, 37, of Oottathur. The preliminary investigation revealed that the vehicle which hit him was
