



# Missing trekkers rescued from Goa forest by staff

Goa forest dept registers a case against 9 for illegal entry in jungles

"IT was the most terrifying nightmare we ever had during which the last six-hour wait in the jungles was the worst and the voice saying 'we are here to help you' was the best relief we ever had in our life," said a trekker who was among the nine students who had gone missing in Kankumbi jungles in Khanapur taluk.

A joint operation by Karnataka and Goa Forest department teams succeeded in searching a group of nine college students, which went missing during a trek in the jungles of Parwad near Kankumbi of Khanapur taluk on Saturday.

The rescued youths are students of 1st year of a noted private college in Belagavi. According to sources from the forest department, the students had planned to go for a trek in Kankumbi forest to watch Janavi waterfalls, which is located on the outskirts of Parwad village on Goa- Karnataka border.

The students reached near Parwad village on their bikes on Friday afternoon. They reached the waterfalls and partied there. Later, while returning, they forgot the route and went missing in the jungles.

Vikas (name changed), said that they had two friends who had visited the waterfall a couple of times and were confident that they knew the route very well. "We followed the regular forest path which was very clear while going inside the forests toward the waterfalls. But while returning, we missed the path and realised that we were lost in jungles. But then too we kept struggling in jungles with hope we will find the route again. After it was dark, we lost hope and tried to search the mobile network and started sending messages to our friends



asking for help. We ensured no one gets separated from each other and no one even preferred to attend nature's call. The unfamiliar noises around us and the fear of wildlife made us do so," he said. A team led by Assistant

Conservator of Forests Santosh Chavan started the search operation from Parwad forest at about 10 pm after the friends of the trekkers informed the officials of the forest department. In addition, the matter of the disappearance of the students was brought to the notice of the Forest Department of Goa too. Hence, a team of Goa Forest de-

partment also conducted an op-

eration from the Goa Forest.

The students were found sitting tired on the rocks in the forest of Java Goa in the early hours of Saturday. They were brought to the Kankumbi Range Forest Officer's office and were provided with first aid.

# Protesting its leader's arrest, KRV blocks road

ACTIVISTS of the Karnataka Rakshana Vedike (KRV) staged a dharna protesting against the arrest of their State president T A Narayana Gowda and other members, at Kittur Rani Channamma Circle in Belagavi on Sunday.

The agitators shouted slogans against the Karnataka government for initiating action against those who are demanding the use of Kannada language on nameplates and mandatory Kannada in administration which they said is very unfair.

They expressed their anger stopping all the vehicles plying at the Kittur Rani Channamma Circle and shouted slogans against the government. The people plying in that area faced severe inconvenience due to the agitation.

Deepak Gudaganatti, KRV district president said that the pro Kannada activists had

launched a public movement in Bengaluru, demanding that the outsiders should obey the government's order using Kannada language to cover 60% space on the nameplates and advertisement boards. But the police have arrested sev-

eral pro-Kannada activists including KRV President Gowda and taken an anti-Kannada attitude, he alleged.

Gudaganatti alleged that apart from Kannada, which is the mother language of the state, Karnataka has been giv-

ing priority to all other languages. This will not be tolerated, he said, demanding the installation of Kannada nameplates in Bengaluru. "We obtained police permission for the protest. But before the protest started, the police arrested the leaders. It is illegal. The government should immediately release the arrested Kannada activists and the cases filed against them should be withdrawn," he demanded.

Gudaganatti warned that if Kannada is not given priority on nameplates, the platform is ready to fight. The fight will be extended to all districts, he said.

Mahadev Talawar, State secretary, KRV said that it is illegal for the police to arrest those who protested for the introduction of Kannada nameplates. This act is an insult to Kannadigas. The arrested activists should be released immediately, he added.

Hundreds of activists participated in the protest.

## 3 injured as car rams tractor

According to police sources, the injured were travelling in the car from Belagavi to Ichalkaranji. When their car reached a bridge beside Gandhi Hospital in Nipani, they came across a sugarcane-laden tractor travelling from Nandgad to Hamidwada Sugar Factory. The driver of the car lost control and rammed the tractor from the backside. The police rushed the injured to a hospital at Kolhapur in Maharashtra. A case has been registered at Nipani Urban police station.
