LOCATED amidst picturesque verdant hills of Eastern Ghats, Araku Valley reflects rich biodiversity and cultural heritage.

The Borra Caves located on the East Coast in Ananthagiri Hills is another tourist attraction in the region. The caves here are not only an architectural marvel but also the largest ones in the country.

Politically, Araku Valley is known to be YSRCP's bastion. The ruling party MLAs continue to be in power for the past two terms. Earlier, the TDP used to gain grip over the constituency. But, not any longer. In 2009, Siveri Soma





from TDP served as MLA in the constituency. In 2014, Kidari Sarveswara Rao and in 2019, Chetti Phalguna, both from YSRCP won in the polls.

Lack of basic infrastructure continues to trouble the tribals as even today, the main mode of transport for many of them here is 'doli' (makeshift stretcher). Pregnant women and those suffering with health issues have to bear the brunt as they need to travel for hours to meet emergency medical needs.

For the past four-and-ahalf years, 117 roads have been laid in 500 villages. "BSC Nursing College is proposed to be set up in Araku Valley and it would be an added advantage to the government once it gets established," said Chetti Phalguna, Araku MLA.

Also, proposals related to island projects in and around Araku are yet to take wings. In Ananthagiri mandal, 70

tribal villages fall under the Non-Scheduled Areas. As a result, the tribals express concern over the protection of their lands. This apart, permission granted for the hydro power project was opposed by the locals in Chintapalli, Koyyur and Ananthagiri mandals.

From 2017, arrears need to be cleared for coffee farmers to the tune of Rs 60 crore.





THE fight for Nellore rural constituency is going to be a fierce one in the 2024 Assembly elections between YSRCP and TDP. While YSRCP is likely to field Adala Prabhakara Reddy, the TDP would be fielding Kotamreddy Sridhar Reddy who sometime back left the YSRCP and migrated to the TDP.

Kotamreddy Sridhar Reddy has the image of being a hard worker and straight forward politician and had represented Nellore rural constituency twice as the YSRCP candidate defeating BJP nominee Sannapu Reddy with a majority of 25,653 votes in 2014 and TDP nominee Shaik Abdul Aziz by a margin of 20,776 votes in 2019. The septuagenarian Adala is a senior politician who made his debut in politics by winning election from Allur Assembly constituency (now merged in Kavali Assembly constituency) on the TDP ticket against Congress nominee Kotamreddy Vishnu Vardhan Reddy in 1999 general elections and became Minister for Housing. Later, he joined the Con-

gress party by quitting TDP and contested from Sarvepalli constituency and won against senior TDP leader Somireddy Chandramohan Reddy twice in 2004 and 2009 with a majority of 7,625 votes (2004) and 10,284 votes (2009).

After 2009 elections, he again went back to the TDP and contested Nellore MP seat on the same party ticket. But he was defeated by YSRCP candidate Mekapati Rajamohan Reddy with the margin of 14,478 votes.

Adala continued in the TDP until 2019 elections and jumped over to the YSRCP after TDP had announced his name as the party candidate for Nellore Assembly constituency. In 2019 elections, he contested for Lok Sabha from Nellore and defeated TDP candidate Beeda Masthan Rao by a margin of 1,48,571 votes. Subsequently, Masthan Rao also joined the YSRCP and he was nominated by the party leadership to the Rajya Sabha.

Again Adala is in the fray as YSRCP candidate from Nellore rural constituency while Kotamreddy Sridhar Reddy is trying for a hattrick in 2024 elections.

Phase-II of Jagananna Aarogya Suraksha begins tomorrow

THE State government has decided to implement the second phase of its flagship Jagananna Aarogya Suraksha (JAS) programme throughout the State from January 2, according to an official release.

JAS-II would cover all households specifically targeting chronic patients, pregnant and lactating mothers, neo-natal and infant care, adolescent health and persons with chronic diseases. Through this programme, the government intends to ensure that the health issues are not only identified at the doorsteps of people but also addressed through the right treatment upon proper consultation and referral to the Arogyasri Network Hospitals. Responsibil A total of 13,954 health camps will be conducted in a span of six months

ity will be entrusted to the Family Doctor as well as the CHO/ANM for handholding the patients to ensure follow-up consultation and making drugs available at village itself as per their

Under the second phase of JAS, the volunteers and representatives will visit every household and explain about Jagananna Aarogya Suraksha camp, the date of the camp and venue details.

The volunteer shall make



door-to-door visits twice before the JAS health camp. The first visit will be done 15 days before the camp date to inform the venue and date and the second visit three days prior as a reminder.

The total mandals will be equally divided to organise one camp every Tuesday of the week in half of the mandals and every Friday in the remaining half of the

mandals in the district.

In urban areas, the camps will be conducted on Wednesday. In each health camp, a minimum of three doctors including 2 specialist doctors and one PMOA (Paramedical Opthalmic Assistant) will be present.

A total of 13,954 JAS-II health camps will be conducted in a span of six months. In rural areas, 10,032 camps and in urban areas 3,922 health camps will be conducted. During January 2024, a total of 3,583 camps shall be conducted.

Various specialists will render their services at the camps. They include General Medicine (543), gynaecologists (645), general surgeons (349), paediatricians orthopaedicians (345) and other specialists (378) will be providing services at the health camps.

Besides, 2,545 specialist doctors and 2,731 MBBS doctors will also take part in the health camps. To conduct eye screening, a total of 562 PMOAs will be deployed at the health camps.

The Family Doctor, CHO and ANM of the village will follow up on all referral cases recommended by the doctors at the health camp to ensure the patient is handheld to visit the Aarogyasri Network hospital and required treatment is given. The patients with chronic illness will get the follow up consultation and medicines free of cost at all Aarogyasri Network hospi-

The required medicines will be directly sent to the village clinic and will be handed over directly to the patient by CHO/ANM along with prescription explanation to the patient.
