A public meeting will be held next to highlight the YSR Congress Party's anti-BC policies, informed BJP parliamentary district president Medapati Raveendra.

Addressing the media at the district party office here on Sunday, the district president said the meeting would be organised on January 7 under the banner of 'BC Samajika Chaithanya Sabha' at AS Raja Grounds in MVP Colony.

OBC Morcha state president Rongala Gopi Srinivas and BJP state vice president P Vishnu Kumar Raju said that injustice was meted out to the BCs during the YSRCP's rule in the state. The Chief Minister YS Jagan Mohan Reddy made a number of promises to BCs during his padayatra but ignored them after coming to power, they pointed out.

They said that there will be no use of setting up 56 corporations for different communities without al-

locating funds for them. The corporation chairpersons and directors were not given any responsibility and it was nothing but an insult to the BCs.

Speaking on the occasion, former MLC PVN Madhav said betrayal of the BCs in the YSRCP's government would be brought to the fore through the public meeting scheduled on January 7.

The BC Corporation, which was supposed to work for the development of BCs, was inactivated, the former MLC said. The BJP leaders alleged that the ruling party divides the BC castes and sub-castes into groups and is creating ruckus between them. They opined that the Bharatiya Janata Party is the only party for BCs and it would be highlighted during the ensuing public meeting.

The colony is situated at Pathahiramandalam revenue village towards eastern side of Vamsadhara reservoir and the house sites are located at low lying area. The Jagananna colony spot will be submerged if Vamsadhara river receive in flow of one lakh cusecs.

The colony spot is situated exact downstream side of Gotta barrage located across the Vamasadhara river. As a result, beneficiaries are least bothered to live here which is leading to slow pace of its construction works. A total of 230 houses were proposed and

not even a single house is completed till date and 30 house works are going on at slow pace.

In return, SMVT Bengaluru-Malda Town Amrit Bharat express (13433) will leave SMVT Bengaluru at 1.50 pm on Tuesdays with effect from January 9 and reaches Visakhapatnam at 10.30 am on Wednesday. It departs at 10.50 am and arrives at Vizianagaram at 12 noon. It departs five minutes later and reaches Srikakulam Road at 1 pm. The train departs at 1.05 pm to reach Malda Town on Thursdays at 11 am.

Mishaps reduced to 15 per cent in Anakapalli

COMPARED to previous year, road accidents decreased to 5 per cent in Anakapalli in 2023, while death rate due to road mishaps reduced to 15 per cent, informed Superintendent of Police KV Murali Krishna.

Addressing the media, the SP mentioned that "Efforts were taken to identify 39 black spots and take up work to rectify them. It is one of the reasons why the death rate has come down in the district."

Taking up special drives, Anakapalli district police made sure that 2.17 Disha apps were downloaded this year. Keeping the women's protection in view, the app was downloaded across the district by educating women, he added.

To control ganja transportation, Murali Krishna mentioned that four permanent and 11 dynamic check posts were set up for the prevention of the cannabis' transport.

According to the police records, murders have gone up in the district. While 15 murders were registered in 2022 and it summed to 25 in 2023, the SP informed.

As far as mobile recovery is concerned, the SP stated that the Anakapalli police recovered 1,238 mobile phones worth Rs.2.2 crore in five phases. He appreciated the staff for their remarkable performance.
