# TSRTC suspends discounted bus tickets in Hyderabad

### FAMILY-24, T-6 TICKETS WILL NOT BE ISSUED FROM TODAY

Hyderabad

TELANGANA State Road Corporation (TSRTC) has suspended two specially discounted tickets in the buses within the suburban limits of Hyderabad from January 1, 2024, given the rush of passengers due to free rides for women.

TSRTC Managing Director VC Sajjanar announced on Sunday that Family-24 and T-6 tickets will be completely suspended from January 1.He said the decision was taken in the wake of increased passenger traffic due to the implementation of the Mahalakshmi scheme.

Sajjanar explained that to issue Family-24 and T-6 tickets, the conductors must see the identity cards of the passengers and must enter their age. "Due to the increase in traffic due to the Mahalakshmi scheme, the conductors are taking a lot of time to issue Family-24 and T-6 tick-



ets. As a result, the journey time of the services is also increasing. The organisation has decided to withdraw Family-24 and T-6 tickets for reasons of inconvenience. These tickets will not be issued from Monday," he said.

The Congress government in Telangana started the implementation of the Mahalakshmi schemeon December 9, offering free travel

for women in TSRTC buses anywhere in the state. The women can travel for free in PalleVelugu and Express categories of buses in districts and City Ordinary and Metro Express buses in the limits of Greater Hyderabad Municipal Corporation (GHMC).

Meanwhile, it may be recalled that the TSRTC introduced T-6 and Family-24 tickets for affordable and

convenient travel options in Hyderabad in March. The T-6 ticket, available for women and senior citizens, offered discounted travel options for those travelling between 10 am and 4 pm on City Ordinary and Metro Express buses within the suburban limits of Hyderabad.

The price of the T-6 ticket was Rs 50, significantly lower than regular fare rates. The Decision taken after increased passenger traffic seen due to 'Mahalakshmi'

F-24 was designed for groups of family, friends who want to travel together

F-24 ticket was designed for groups of family and friends who want to travel together. Priced at Rs 300, it was launched for those who want to travel in groups of four on weekends and public holidays within the suburban limits of Hyderabad. The F-24 ticket allowed travellers to use City Ordinary and Metro Express buses for 24 hours from the time of purchase.

### ₹5 lakh accident insurance for gig workers in Telangana

THE Telangana government has extended the accidental insurance scheme to the gig and platform workers in the state with coverage of Rs 5 lakh. The state government has issued an order for extending the scheme, which is currently being implemented for transport and non-transport auto drivers, home guards, and working journalists. The entire cost of premium for Rs 5 lakh accidental insurance for beneficiaries covered under the scheme is to be paid by the state government.

The state government has designated the Commissioner of Transport as the master policyholder and Assistant Motor Vehicle Inspectors of the Transport Department as the registering authority and claim receiving authority for gig and platform workers.

The orders were issued a week after Chief Minister A. Revanth Reddy made the announcement during a meeting with gig workers.

He had stated that the state government would provide social security to workers in the unorganised sectors. He had also assured that the



government would provide Rs 10 lakh health cover to Gig workers under the Rajiv Arogyasri Scheme.

Revanth Reddy also promised that the state government would study the existing policy for gig workers in Rajasthan and introduce an effective law in the next budget session. He had also announced Rs 2 lakh financial assistance to the family of a food delivery executive who died four months ago after he fell from a building.

As per his promise, the Chief Minister on Saturday handed over a cheque of Rs.2 lakh from the Chief Minister's Relief Fund to the family of Mohammed Rizwan The Swiggy delivery executive had died after he fell from the third floor of a building where he had gone to deliver food while trying to escape the customer's pet dog.

During the campaign for the Telangana Assembly elections last month, Congress leader Rahul Gandhi had assured that if voted to power, Congress will consider bringing legislation for the welfare of Gig workers on the lines of a law passed recently in Rajasthan. During an interaction with Gig workers, he had told them that after the Congress comes to power, the Chief Minister and ministers concerned will hold a meeting with them and decide on the welfare
