They include Farooq Ahmad Dar alias Bitta Karate, Altaf Ahmad Shah alias Fantoosh, Geelani's son-in-law and public relations officer of the TeH as well as secretary and strategist in the Hurriyat, Mohammad Akbar Khanday, spokesman of the Hurrivat and a fund-raiser for it, Raja Mehrajuddin Kalwal and Bashir Ahmad Bhat alias Peer Saifullah, personal assistant of Geelani as well as secretary of the TeH. Geelani died in September 2021 while his son-in-law in October 2022.

The Union home ministry, in a notification, highlighted the group's involvement in raising funds from various sources, including Pakistan and its proxy organisations, to support unlawful activities such as sustaining terrorist acts and orchestrating stone-pelting incidents against security forces in the region.

In addition, the notification underscored the group's disregard for constitutional authority and its repeated calls to boycott assembly elections, displaying a lack of belief in the democratic system of governance.

The central government's decision to ban the Tehreeke-Hurriyat for five years stems from its concern that the group, if left unchecked, would persist in advocating for the secession of Jammu and Kashmir from India while disputing its accession to the Union.

The group's activities were deemed prejudicial to the integrity, sovereignty, security, and communal harmony of the country, with a potential to perpetuate a false narrative and anti-national sentiments among the people of Jammu and Kashmir. In exercising powers conferred by the Unlawful Activities (Prevention) Act, 1967, the central government officially declared the TeH, Jammu and Kashmir, as an unlawful association for the next five years, effective immediately.

This measure reflects the government's commitment to curbing activities that pose a threat to the territorial integrity, security, and sovereignty of the nation, aiming to maintain public order and discourage sentiments of disaffection against India.

During these years, he also served as India's G20 Sherpa and led the Indian teams that negotiated the G20 communiques during the presidencies of Turkey (2015), China (2016) and Germany (2017).

But, of late, Indian vessels too have come under attack. MV Chem Pluto was attacked about 200 nautical miles (370km) off the coast of the western state of Gujarat. The attack triggered a fire but it was quickly extinguished by the crew. There were no casualties. Going on the offensive — though steering clear of a larger US naval game plan — Indian Navy has deployed a total of four destroyers, one frigate and one I long-range patrol aircraft in the Arabian Sea and Gulf of Aden. Also on the job are a Predator Drone — for surveillance in the Arabian Sea — and Dornier aircraft and helicopters. It is perhaps for the first time that frontline destroyers and frigates have been deployed to undertake maritime security operations and help merchant vessels. The destroyers deployed in the region include INS Mormugao, INS Kochi and INS Kolkata. Following the hijack bid, shipping giant Maersk said it is suspending the passage of vessels through a key Red Sea strait for 48 hours. The decision came just days after Maersk said that it was resuming voyages through the Red Sea and the Suez Canal. For about a week before that announcement, the company s ships had been avoiding the area because of safety concerns.

He also shared on the microblogging site the complaint sent to the Uttar Pradesh police chief, a copy of which was marked to Adityanath and Home Minister Amit Shah. "Beware! The incident took place on the night of November 1. Following the incident, hundreds of Banaras Hindu University (BHU) students had held a protest on the campus and demanded that the entry of outsiders be banned. According to the complainant, she had gone out of her hostel with a friend on the night of November 1. They were near the Karman Baba temple when three men came there on a motorcycle, forcibly took her to a corner and gagged her after separating her from her friend. The accused then allegedly stripped the woman, made a video of her and clicked photos. They let her go after about 15 minutes and took her phone number, the complainant stated. On the basis of the complaint, an FIR was registered under Section 354 (assault or criminal force to a woman with intent to outrage her modesty) of the Indian Penal Code and under provisions of the Information Technology Act at Lanka police station. Subsequently, the charge of gangrape was added to the FIR, police said.

Situation tense in Manipur

IMPHAL

The situation in Manipur's Moreh town continues to be tense a day after three commandos of Manipur Police were injured in a rocket-propelled grenade (RPG) attack at one of their posts in the border town on Saturday night, officials said.

Suspected militants fired several RPGs which exploded inside the CDO outpost building at Moreh Turelwangma Leikai where the commandos were staying, officials said on Sunday.

"The commandos are now being treated at the Assam Rifles KPL camp and are stated to be out of danger," police said.

A number of police vehicles were also damaged during the attack, they said. Police added that six



suspected militants were injured in retaliatory firing. "Fatalities are also being reported but it could not be immediately confirmed. Further details are

awaited," an official said. In another development, a village volunteer was injured in a gunfight between two groups at Tabungkhok area in Imphal East district in the wee hours of Sunday, police said.

C Lamyanba was tasked with guarding the village when the gunfight broke out, officials said. He has been admitted to Raj Medicity for treatment and is "under observation", a hospital staff said.
