# APMC's five-star hotel

Gujarat high court on Wednesday ordered the state govt to take possession of Surat's Agriculture Produce Market Committee's (APMC) five-star hotel constructed on the market yard's land. It also ordered a public auction of the property and directed authorities to deposit the amount to state's market funds. The bench of Chief Justice Sunita Agarwal and Justice Aniruddha Mayee further ordered action against erring officials and APMC members responsible for the construction of the luxurious hotel, which violated the aims and objectives of the market yard, for which the govt had acquired about 14,000 sq mt land. The HC ordered the director of Agriculture, Marketing and Rural Finance to conduct inspection of the Krushi Bazar on allegations by a petitioner that the shops in the mall were leased for the sale of items like jewellery and clothes. The HC ordered the closure of all activities in the

sought the inspection report by next month.

This issue had reached the HC in 2014 with the petitioner accusing Surat APMC of constructing a mall and a fivestar hotel on 20,000 sq mt land and shifting the market yard to another place. The govt had acquired lands for the APMC at both places. The APMC constructed the hotel by spending Rs 90 crore and leased it to a private group — Hotel Shilpi's Pvt Ltd — to run it. However, the HC had stayed the arrangement. When the HC ordered the govt to take possession of the hotel and put it to auction, the hospitality group expressed concerns about its investment. The bench of Chief Justice Sunita Agarwal and Justice Aniruddha Mayee further ordered action against erring of-ficials and APMC members responsible for the construction of the luxurious hotel, which violated the aims and objectives of the market yard, for which the govt had acquired about 14,000 sq mt land.

Ahmedabad: The heat is on. On Wednesday, nearly all major cities of Gujarat recorded maximum temperatures of 40°C and above. This is the first time the city recorded 40°C this season, three degrees above normal; on Tuesday, it was 39.9°C. Bhuj in Kutch was the hottest at 42°C with the day temperature five degrees above normal. Rajkot and Surendranagar residents endured 41°C.

The sudden rise in temperatures had people rescheduling their plans for the day. "I travelled to Vadodara by road for work hoping for a pleasant drive but the sudden rise in mercury made the drive stifling as the AC could not keep up with the searing heat," said Pritesh Parekh, a sales executive.

In Ahmedabad, several commuters who ventured out after noon complained of fatigue. Officials asked people to increase their fluid intake to keep themselves hydrated and adapt to the weather.

"People should drink water, lemonade or buttermilk before stepping out to avoid getting dehydrated as it can lead to muscle pain and general malaise. Using an umbrella or a cap is advisable," a physician said.

# HC orders auction of Surat Why should we spare you for your Ahmedabad: The fare of the farmers. The HC inaction: HC tears into home secy



Ahmedabad: Annoyed with the state home department's incomplete answers to its queries, the Gujarat high court on Wednesday directed the home secretary to explain why action should not be taken against him for not complying with the SC's directions to remove illegal religious structures from public land in a phased, timebound manner.

The bench of Chief Justice Sunita Agarwal and Justice Aniruddha Mayee took exception to the "sketchy" affidavit filed by the home department when the HC asked for details regarding action taken by the department to remove unauthorized religious structures.

The judges were irked when they read in the affidavit that the home department needs to consult the revenue department since the land on which these structures stood fall under the latter's purview.

Besides, the home department said that it needed to consult the state urban development and housing department, which would need to communicate to the municipal corporations, municipalities and districts about compliance with the SC

The judges took notice of inadequate information supplied in the affidavits and criticized the attitude of the officials who were coming up with such affidavits in every

When a govt lawyer sought permission to file a new affidavit, the CJ said, "Are you joking with us? You don't look at the order when you file an affidavit to see if it answers our queries."

hearing.

For the evasive reply by the home department, the court said, "We fail to understand how the home secretary, who is otherwise responsible for the law and

order situation, can give such a response as the removal of encroachment on govt land would result in a law and order problem. The shifting of responsibility by the home secretary is nothing but utter violation of the judgment of the Supreme Court in 2010."

The court further wrote, "We therefore require the home secretary to explain why action be not taken against him for noncompliance with the Supreme Court order and not ensuring that the proceedings of removal of unauthorized structures lying on public land are carried out in a phased and time-bound manner."

The court has sought a response by April 22, when the home and revenue departments are supposed to inform the court about action

The HC had taken suo motu cognizance of the issue on the basis of a TOI report in 2006, when violence erupted in Vadodara over removal of three graves from the road. The issue reached the apex court, which in 2010 directed all state govts to remove encroachments from public land.

#### GIDB expands scope of assistance to logistics projects

Gandhinagar: The Gujarat Board's (GIDB) governing board has okayed a proposal broadening the scope of projects that are covered under the logistics sector. It has sent a proposal to this effect to the state industries and mines department for making necessary changes to the GID Act, 1999.

According to top govt sources, the phrase Logistics Infrastructure and Facilities' will be added to the list of specific logistics projects which have been mentioned.

"With this modification, all sorts of projects related to logistics will get guicker approvals and incentives from govt. Addition of the phrase Logistics Infrastructure and Facilities' will ensure that private participation in the sector will get a boost," officials said.

A meeting was held recently in Gandhinagar, where GIDB board members authorized the chief executive officer to the following proposal to the industries and mines department for approval: "Logistics infrastructure and facilities', including but not limited to integrated logistics park, multi modal logistics park, inland container depot, freight terminal, container freight station, air freight station, air cargo complex, cold chain facility, warehouse, truck terminal, silos, and the like infrastructure."

Officials said that the addition of the phrase 'Logistics infrastructure and facilities' will enable logistics infrastructure to be included in the priority sector, where govt is entitled to take decisions to expedite projects through incentives. "It will also enable logistics projects to be implemented through the PPP (public private participation) model," sources said.

Ahmedabad: People across Gujarat celebrated with friends and family as the ong weekend was marked by Holi and Dhuleti festivities on Sunday and Monday respectively.
