HC grants conditional bail to biker

Chennai: After 40 days in jail, biker and YouTuber T TF Vasan is set to walk free as Madras high court granted conditional bail to him on Wednesday. He has been directed to appear before the investigation officer daily for three weeks.

Justice C V Karthikeyan granted the relief since the court was informed that the petitioner, even if released on bail, cannot ride bikes as the state transport department has suspended his driving license for 10 years.

The prosecution also informed the court that it had no objection in granting the relief to the petitioner. On September 17, Vasan fell from his sports bike after a failed attempt to perform a wheelie on the Chennai-Bengaluru National Highway. He was booked under various Sections of IPC, including Section 308 (attempt to commit culpable homicide), Section 279 (rash driving), and Section 337 (causing hurt by endangering act). TNN

Snapped power cables claim 7 lives every month

Tangedco Says It Is Taking Steps To Avert Electrocutions

Chennai: At least seven people are killed every month in the state by electrocution after stepping on overhead power cables that have snapped and fallen to the ground, according to Tangedco. In the last three months alone, there have been 31 such deaths. In 2022-23, there were 89 deaths. In fact since 2006, a total of 1,589 people and 2,485 animals have died in this way.

Consumer activists and experts blame it on lack of adequate checks and maintenance, and negligence by Tangedco staff. Last week, Coimbatore Consumer Cause secretary K Kathirmathiyon wrote to Tangedco chairman Rajesh Lakhoni that some electrocution deaths in Coimbatore could have been prevented if there had been proper guarding and earthing in place for the transmission lines, he said. Snapping of po-



adequate checks and maintenance, and negligence by Tangedco staff

wer lines could have been prevented if the discom had laid them as per International Energy Agency norms, he ad-

Appavoo Subbiah, retired chief of the electrical inspectorate, said precautionary exercises should be carried out and weak power lines should be periodically replaced. "The conductors (cables) are designed to withstand wind speed up to 120 kmph. So, unless it is a cyclone, the conductors should not snap. But maintenan-

ce is key," he added. In September, in a circular to all 12 chief engineers of distribution regions, Tangedco had said that whenever a power cable snapped, the corresponding distribution transformer as well as the lines linked to the transformer should thoroughly inspected. They must also ensure the earthing of the poles. It also said weak jumpers and insulators should be replaced. And, additional poles should be erected where the distance

Tangedco officials said steps are being taken to prevent electrocution deaths. 'We are working towards zero deaths. For Tangedco personnel climbing the electric poles and transformers, the crucial safety measure is using earth rods. We have insisted that Tangedco personnel upload photos of earth rod before climbing any of our structures and we are rolling out a mobile phone application to upload photos with timestamps. In case of violation there will be action against the supervisor," said an official. Tangedco is also planning to install circuit breakers for transformers. "We have installed the breakers at 100 transformers on the elephant corridor on a trial basis. If found to be effective, they will be installed for transformers across the state, though it is expensive," said the official.

RSS contempt plea: DGP summoned

ted the authorities to grant permission for the march with reasonable conditions on October 22 and 29

When the plea came up for hearing before G Jayachandran on Wednesday, counsel for RSS said the authorities had failed to grant permission for the march despite the court order. The Supreme Court has not stayed the operation of the high court order.

Representing the state, an additional public prosecutor moved an appeal against the October 16 order before the Supreme Court and the same was listed for hearing on Novem-

Recording the submissions, the court ordered statutory notices against the home secretary and the DGP and directed them to respond to the

plea in four weeks. According to the representing the organisation, they approached authorities concerned in several districts to conduct a route march on October 22 followed by a public

meeting. Since permission was denied, they moved the high court which in turn directed the authorities to permit the marches with reasonable conditions, he said. Asserting that the authorities are duty-bound to obey the orders of the high court, the organisation alleged that the authorities have committed contempt of court by not implementing the order directing to grant permission for the marches October 22.

"The BJP's politics is to fish in troubled waters but Tamil Nadu is like a clear water in which they find it hard to do politics.
