# Session valid, proceed to examine bills: SC

**New Delhi:** Coming down heavily on the Punjab governor for withholding assent to bills passed by the assembly, the Supreme Court said Friday that "casting doubt on the validity of the session of the House is not a constitutional option open to the Governor".

"Do you realise the gravity of what you are doing," the bench of CJI DY Chandrachud, and Justices J B Pardiwala and Manoj Misra asked. "The governor says the session of the legislative assembly, which has passed four bills, that session itself is void because the assembly ought to have been prorogued and not adjourned sine die."

"The bills are passed by a duly elected legislative body. If you have reservations on the bill on the ground that it is unconstitutional, you have your remedies under the Constitution. You can reserve it for consideration of the President, you can return it to the assembly. But surely, you can't sit on judgment over it and say this legislative assembly session is unconstitutional. If we allow this power to the governor, what will happen? Will we continue to be a parliamentary form of government?"

# At 2+2 meeting, India, US support humanitarian pauses in West Asia

**New Delhi:** Indo-Pacific and Quad cooperation, Chinese assertiveness in the region, counterterrorism, connectivity with focus on the recently launched India-Middle East-Europe Economic Corridor (IMEC) and other global and regional issues like the situation in West Asia and the Russia-Ukraine war dominated the 2+2 talks on Friday.

Expectedly, the Israel-Hamas conflict found prominent mention in a joint statement that noted the "horrific" terrorist attacks against Israel and had the ministers reiterating that India and the US stood with Israel against terrorism, and seeking immediate release of all hostages. To balance out, they also called for adherence to international humanitarian law and protection of civilians.

"They expressed support for humanitarian pauses and committed to continue close diplomatic coordination, including with key partners in the region, to prevent the conflict from spreading, preserve stability in the Middle East, and work toward a political solution and durable peace," the joint statement said as it emphasised the importance of humanitarian aid to meet the urgent needs of civilians in Gaza.

The support for humanitarian pauses is significant as the US had earlier voted against a resolution in the UNGA for a humanitarian truce and India had abstained from voting on it because the resolution didn't condemn the terror attacks on Israel.

In talks with secretary of state Antony Blinken and secretary of defence Lloyd Austin, foreign minister S Jaishankar and defence minister Rajnath Singh also underscored India's support for early resumption of talks for a two-state solution, zero tolerance to terrorism and international humanitarian law. Jaishankar said the agenda covered advancing the strategic partnership, including efforts to elevate defence ties.
