1986 CHANDAULI KILLINGS: HC ACQUITS 9

HC overturns lower court order, convicts 4

EXPRESS NEWS SERVICE LUCKNOW, NOVEMBER 20

AFTER HEARING appeals against the acquittal of 13 persons, including gangster-turned politician Brijesh Singh, in connection with the murder of seven members of a family in Chandauli district in 1986, the Allahabad High Court convicted four persons and acquitted nine others, including Brijesh Singh. Three of the acquitted persons died during the pendency of appeal. The court issued the order on November 9 but it was made public on Monday.

In 2002, 12 accused in the case were acquitted by a local court in Varanasi and Brijesh Singh was acquitted in the same case in 2018. The murder trial of Brijesh Singh, a former MLC, was conducted separately from that of the other accused persons because he (Brijesh Singh) remained absconding for a long time.

In 2002, the state government filed an appeal against the acquittal of 12 persons and in 2018, it filed an appeal against the acquittal of Brijesh Singh. The complainant in the case, Heerawati, too filed an appeal against Brijesh Singh in the Allahabad High Court in 2018.

On November 9 this year, a divi-

sion bench of Chief Justice Pritinker Diwaker and Justice Ajay Bhanot said in its order, "...considering the overall facts and circumstances of the case, we are of the view that the acquittal of four accused persons namely, Pancham Singh, Vakil Singh, Rakesh Singh and Devendra Pratap Singh, is not in accordance with law and while acquitting them, the trial court has erred in law. Accordingly, the present appeal is partly allowed." The court added, "The acquittal

of four accused - Pancham Singh, Vakil Singh, Rakesh Singh and Devendra Pratap Singh, is set aside. They are convicted under Section 302 read with Section 34 of IPC and Section 307 read with Section 34 of IPC and sentenced to undergo life imprisonment, with a fine of Rs 50,000 each under Section 302/34 of IPC, and to undergo rigorous imprisonment of 10 years..."

The court said, "So far as the remaining alive accused persons namely, Ram Das, Dina Singh, Kanhaiya Singh, Narendra Singh, Vijay Singh, Musafir Singh are concerned, the evidence against them is not clinching and not sufficient to hold them guilty..."

The court also stated in its order that a bare perusal of the evidence available on record, it is clear that the trial court has wrongly acquitted the aforesaid four named accused persons, — Pancham Singh, Vakil Singh, Rakesh Singh and Devendra Pratap Singh — giving them benefit of the evidence adduced by the prosecution against the aforesaid alive acquitted accused persons: Ram Das, Dina Singh, Kanhaiya Singh, Narendra Singh, Vijay Singh, Musafir Singh. The appeal filed by the state against the acquittal of accused persons, namely, Ram Das@Dina Singh, Kanhaiya Singh, Narendra Singh, Vijay Singh and Musafir Singh, is dismissed, said the court.

Upendra Upadhyay, lawyer of the complainant Heerawati, said accused, "We are partially satisfied with the judgment."

The case dates back to intervening night of January 9 and 10, 1986, when assailants entered the house of the complainant Heerawati, a resident of Sikrarua village, and killed seven members, including four children and three adults, of the family.

She alleged that attack was the fallout of an old enmity between deceased Ram Chandra Yadav and accused Kanhaiya Singh with regard to pradhani election and a land dispute.

2 fake call centres busted after US nationals file complaints

DHEERAJMISHRA NOIDA. NOVEMBER 20

■ US citizen Devon Mitchell Waren Yeats was cheated through a call centre and his money from Bank of America was transferred to an HSBC account in Hong Kong.

■ US Nationals Samir Gupta and John Jonas were also duped and their money transferred to the Hong Kong account.

Both cases were part of scams, aimed at duping American citizens, that was uncovered during a joint operation by the Noida Police and Uttar Pradesh Special Task Force after it busted two fake call centres in Noida — Phase 1 and Bisrakh — in a week. The centres were being run in an organised manner with high-end hackers involving Russians and Chinese, said police.

Officials said the three victims had contacted the UPSTF via email and filed complaints, which led to the arrest of 40 persons; others are on the run.

Additional SP (STF) Raj Kumar Mishra, who led the case, said. "In the Bisrakh case, as the main accused was arrested, we got records which showed a turnover of Rs 2 crore a month. But it will take time to find out the scale of the fraud as this has been going on for years. In the first case, we are yet to

Describing the modus operandi in the first case, police said the accused used to buy US citizens' data and identify US service providers through a website called White Pages. Then they used to call the users, posing as service providers, and get their PIN number which is also linked to their bank accounts.

After that, they used to make another call to the service provider, posing as the user, to book a new high-cost phone. Then their agent in the US used to receive those phones at a particular address, which he then sold. This amount was transferred to the scamsters in USDT (Tether) and hawala networks.

The money for the phones, meanwhile, went from the user's account.

After Yeats filed a complaint, police raided the third floor of a building in Phase 1 police station area Saturday and arrested 16 people, including five women. Officials said the mastermind, Nitin Srivastava, is on the run

Second-in-command. Divya Sharma alias LuvKush (28), a graduate in History from Delhi University, was ar-

rested. During questioning, he told police he met Srivastava through his mother. An FIR under IPC sections 419, 420, 467, 468, 120B and 34 and section 66D of IT Act has been registered. Police recovered a car, 18 phones, 17 original/fake driving licences of US nationals, 27 phone order data sheets, 10 pages of calling data, 20 credit cards,

among other things.

In the second case, officials said the fraud was being executed through callgenerating hackers, call centres and payment mode system. Police said call centre employees

would first get in touch with call-generating hackers, mostly Russians, with access to US citizens' data. Using this, the centre used to bombard phones of US citizens with SMSes, emails and popups offering mobile banking and, insurance solutions.

As soon as anyone called the number, it would be connected to the call centre through cloud-based dialer system. The call centre used to tell the US nationals that they would have to pay a fee to avail the service. Here is where the accused based out of Hong Kong came into the picture — they provided a payment mode system to receive the fraudulent money.
